A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, DIRECTING THE CITY MANAGER AND THE CITY ATTORNEY TO NEGOTIATE A CONTRACT AMENDMENT WITH WASTE MANAGEMENT OF FLORIDA, INC. (WMI) TO PROVIDE FOR TWICE PER WEEK SOLID WASTE COLLECTION SERVICES FOR RESIDENTIAL UNITS; AUTHORIZING THE CITY MANAGER TO EXECUTE THE AMENDMENT TO CONTRACT; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on May 6, 2014, the City Commission awarded the bid of Waste Management Inc. (WMI) of Florida in response to ITB 14-009, and on June 25<sup>th</sup> a Contract was executed for the collection, transfer and disposal of solid waste and recyclable materials and transfer station operation; and

WHEREAS, in Resolution 14-254, the City Commission approved a First Amendment to Contract, which included a provision for residential solid waste collection once per week; and

WHEREAS, the City Commission finds that due to public health and safety concerns it would be in the best interests of the City to provide for residential solid waste collection twice per week; and

whereas, the City Commission finds it necessary to direct the City Manager and the City Attorney to negotiate a Second Amendment to Contract between the City and WMI to provide for twice-weekly residential solid waste collection, in order to protect the health, welfare and economic concerns of the residents of Key West;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Manager and the City Attorney are hereby directed to negotiate a contract amendment with WMI which shall include the provision of twice per week solid waste collection services for residential units.

Section 2: That the City Manager is directed to bring a negotiated "Second Amendment to Contract" to the City Commission for approval upon the advice and consent of the City Attorney.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
