A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, REJECTING THE PROPOSAL RECEIVED IN RESPONSE TO REQUEST FOR PROPOSAL #15-020 FOR REFURBISH I-BEAMS AT CITY MARINA PURSUANT TO SECTION 2-OF THE CODE OF ORDINANCES; APPROVING THE PRICE QUOTE OF S.B. PAINTING AND GROUNDS MAINTENANCE, INC. IN AN AMOUNT NOT TO EXCEED \$25,550.00 TO REFURBISH 146 I-BEAMS AT CITY MARINA PURSUANT TO SECTION 2-797(4)(B) OF THE CODE OF ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, City staff obtained price quotes from several vendors, and because each quote was over \$20,000.00, City staff then published RFP 15-020 to Refurbish I-Beams at City Marina; and WHEREAS, the sole response to RFP 15-020 significantly exceeded all of the previously-obtained price quotes, and accordingly City staff recommends rejecting the response to the RFP, in the best interests of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the proposal received in response to Request for Proposals #15-020, for refurbishing I-Beams at City Marina is hereby rejected pursuant to city code of ordinances section 2-834(4), best interests of the City.

Section 2: That an exemption to competitive bid requirements, and the expenditure of funds not to exceed \$25,550.00 to S.B. Painting and Grounds Maintenance, Inc. to refurbish I-beam roof supports at the City Marina at Garrison Bight, is hereby approved, pursuant to section 2-797(4)(b) of the Code of Ordinances.

Section 3: That funds in the amount of \$25,000.00 are budgeted for the project in account 413-7551-575-4600. The use of additional funds in the amount of \$550.00 from account 413-7551-575-4600 is hereby authorized.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
