**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of Key West, Florida;

SECTION 1. That permission is hereby granted to conduct the Half Marathon and 5K on the date and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager.

**SECTION 2.** That the Key West Half Marathon LLC. is hereby granted permission for the closure of certain streets throughout the city for the Half Marathon & 5K on the date and during the hours stated above.

**SECTION 3.** That the Key West Half Marathon LLC will be coordinating with the agencies outside of the City of Key West jurisdiction for their part in the race.

**SECTION 4.** That the Event organizers will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.
