**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING LONE PALM FOUNDATION, INC. TO CONDUCT PARROT HEADS IN PARADISE STREET PARTY ON FRIDAY, NOVEMBER 6, 2015 FROM 8:00 A.M. TO 6:00 P.M. PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE CLOSURE OF THE 400 & 500 BLOCKS OF DUVAL STREET; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 8:00 A.M. TO 6:00 P.M.; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS,** Lone Palm Foundation, Inc. wishes to conduct Parrot Heads in Paradise Street Party as a fundraiser on Friday, November 6, 2015 on the 400 & 500 blocks of Duval Street.

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of Key West, Florida;

**SECTION 1.** That Lone Palm Foundation, Inc. is hereby granted permission to conduct Parrot Heads in Paradise Street Party on the day and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager; and that 25% of gross revenue or \$1,000.00, whichever is greater, shall be donated to Lone Palm Foundation, Inc.

**SECTION 2.** That Lone Palm Foundation, Inc. is hereby granted permission for the closure of the 400 & 500 blocks of Duval Street on the date and during the hours stated above.

**SECTION 3.** That Lone Palm Foundation, Inc. is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take

place and time herein described.

**SECTION 4.** That pursuant to Section 18-86 of the Key West Code of Ordinances, Lone Palm Foundation, Inc. is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

**SECTION 5.** That Lone Palm Foundation, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

**SECTION 6.** This Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
