A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDED THE BID OF P2M GENERAL CONTRACTING SERVICES, INC. FOR PAINTING KEY WEST FIRE DEPARTMENT EXTERIOR AND POLICE STATION INTERIOR/EXTERIOR, IN ACCORDANCE WITH THE TERMS SPECIFIED IN ITB 15-023, IN AN AMOUNT NOT TO EXCEED \$59,500.00; AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT IN SUBSTANTIAL CONFORMANCE WITH THE CONTRACT DOCUMENTS CONTAINED IN THE BID PACKAGE AND UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on July 1, 2015 three bids were opened in response to ITB #15-023, for Painting of Key West Fire Department Exterior and Police Interior/Exterior, and the bids were determined to be responsive; and

WHEREAS, the bid submitted by P2M General Contracting Services, Inc. was the lowest responsive bid; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the bid of P2M General Contracting Services, Inc. for Painting of Key West Fire Department Exterior and Police Interior/Exterior in accordance with the terms specified in ITB #15-023 is hereby awarded in an amount not to exceed \$59,500.00.

Section 2: That adequate funds are allocated for this project in General Fund Account #001-1909-519-46, for repair and maintenance.

Section 3: That the City Manager is authorized to execute a contract in substantial conformance with the contract documents contained within the bid package on behalf of the City of Key West, upon the advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
