A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF A DOCKMASTER OFFICE/TRANSIENT BATHHOUSE STRUCTURE FOR THE CITY MARINA AT GARRISON BIGHT FROM UH STRUCTURES - D/B/A EBTECH INDUSTRIAL BUILDING SOLUTIONS PURSUANT TO GSA CONTRACT, IN COMBINATION WITH OPEN MARKET ITEMS NECESSARY TO COMPLETE CONSTRUCTION, IN AN AMOUNT NOT TO EXCEED \$589,857.79, PURSUANT TO SECTION 2-797(3) AND 2-797(4)(B) OF THE CODE OF ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City Commission accepted grant funding through the Florida Fish and Wildlife Conservation Commission, Boating Infrastructure Grant Program (BIGP) for the construction of a transient bathhouse structure and electrical upgrades to the Transient Docks at Garrison Bight; and

WHEREAS, City staff has determined that the most costefficient and expeditious method to complete the Garrison Bight
structure is through the purchase of structures from UH Structures
d/b/a Ebtech Industrial Building Solutions, pursuant to General
Services Administration (GSA) Contract, pursuant to section 2797(3) of the Code of Ordinances, in combination with certain open
market items, pursuant to section 2-797(4)(b).

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase is hereby approved of a Dockmaster Office/Transient Bathhouse Structure for the City Marina at Garrison Bight from UH Structures d/b/a Ebtech Industrial Building Solutions, pursuant to GSA Contract in combination with open market pricing of certain components, pursuant to section 2-797(3) and 2-797(4)(b) of the Code of Ordinances.

Section 2: That up to \$190,000.00 of the funding for this purchase is anticipated to be funded through the BIGP grant, with the balance budgeted in account 413-7551-575-6200.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
