A RESOLUTION OF THE CAROLINE STREET CORRIDOR AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY (CRA), AWARDING THE BID OF FLORIDA DREDGE AND DOCK, LLC IN RESPONSE TO ITB #15-019: KEY WEST HISTORIC SEAPORT PILING REPLACEMENT (PROJECT #KB-1505) IN THE AMOUNT OF \$374,785.00; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on July 29, 2015, three bids were opened in response to ITB #15-019: Key West Historic Seaport Piling Replacement, Project No. KB-1505, with Florida Dredge and Dock, LLC submitting the lowest bid; and

WHEREAS, at a meeting on August 5, 2015, the Key West Bight Management District Board recommended award of bid to the low bidder, Florid Dock & Dredge, LLC,

NOW, THEREFORE, BE IT RESOLVED BY THE CAROLINE STREET CORRIDOR AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY, AS FOLLOWS:

Section 1: That the bid of Florida Dredge and Dock, LLC in the amount of \$374,785.00 is hereby awarded, and the City Manager is authorized to enter into a contract in conformity with the bid documents upon the advice and consent of the City Attorney.

Section 2: That a 10% contingency allowance is hereby authorized.

Section 3: That funds for this project are budgeted for FY 2015 in account 405-7503-575-6300 KB1505.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Agency.
