My guess is they already got rid of the siding that was there."

As of May 7 the permit has not been issued. Reason: Must go to HARC Commission per Kelly Perkins (can not be staff approved).

Wayne Garcia is a Certified Building Contractor with active State and City license.

Contractor requested (by email before meeting) to postpone since he was out of town.

Acevedo made motion to hold the hearing.

Failed due to lack of second.
