SECTION 3. That pursuant to Section 18-86 of the Key West Code of Ordinances, Exclusive Sports Marketing Inc. of Florida is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

SECTION 4. That Exclusive Sports Marketing, Inc. of Florida will adhere to the recycling plan of the City of Key West and that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.
