A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE CITY MANAGER TO REVIEW THE CURRENT AND FUTURE NEEDS OF THE BOYS AND GIRLS CLUB OF THE KEYS AND THE ABILITY OF THE CITY TO EXPAND FACILITIES AT BAYVIEW PARK FOR THEIR USE FOR THE BENEFIT OF THE YOUTH OF THE COMMUNITY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Boys & Girls Clubs of the Keys Area, Inc., provides significant leadership in the education and well-being of our youth, grounded in the principle that quality afterschool programs are key to helping our children become successful adults; and

WHEREAS, the Boys & Girls Club supports working families by ensuring their children are safe and productive after the regular school day ends; and

WHEREAS, the Boys & Girls Club provides safe, challenging, engaging and fun learning experiences to help children and youth develop their social, emotional, physical, cultural, and academic skills; and

WHEREAS, the Boys and Girls Club executed a ten (10) year lease agreement with the City in 2011 for a portion of City property at Bayview Park, from which it operates some of its

programs; and

WHEREAS, the Boys and Girls Club's other operations have moved from facility to facility over the past few years without the benefit of a permanent home; and

WHEREAS, the Boys and Girls Club is currently operating a portion of its programs out of the former Reynolds School site; and

WHEREAS, the School District has indicated that it may need to reestablish programs at Reynolds School that could again displace the Boys and Girls Club;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Manager is authorized and directed to review the current and future needs of the Boys and Girls Club of the Keys and determine the ability of the City to expand facilities at Bayview Park for their use.

Section 2: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
