I have worked my may up the ladder, first getting my CSR 440 license from the state to now holding my 220 Agents license and being the Personal Lines Manager for the agency.

In addition to that I have help with AIDS help events, toys for tots, and I hold a set on the round table for Citizens Property Insurance, being a liaison of Monroe County. When Citizens wanted to drop homes valued over \$750,000.00 they reached out to me. I expressed my thought and concerns and Miami Dade
