



An application was received for the removal **of (1) Sea Grape tree**. A site inspection was done on September 23, 2015 and documented the following:

Tree Species: Sea Grape (Coccoloba uvifera)









Diameter: 16.8" Location: 50% (fighting for space with other large canopy trees, close to structure) Species: 100% (on protected tree list) Condition: 50% (fair-trunk with lean and curve, fighting for light,) Total Average Value = 66% Value x Diameter = 11 replacement caliper inches

Recommendation: Recommend approval of the removal of one (1) Sea Grape tree at 1226 South Street to be replaced with 11 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted onsite.


