A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RATIFYING SOLE SOURCE EMERGENCY PURCHASES APPROVED BY THE CITY MANAGER IN EXCESS OF \$20,000 AS ALLOWED UNDER SECTION 2-797(1) and (2) OF CITY'S CODE OF ORDINANCES, FROM GILLIG, LLC FOR THE PURCHASE OF THREE (3) BUS AIR CONDITIONING COMPRESSORS AT A COST OF \$19,999.98 AND FROM CUMMINS POWER SOUTH FOR THE PURCHASE OF TWO BUS ENGINES AT A COST OF \$44,839.73 (TOTAL PURCHASE AMOUNT OF \$64,839.71); RATIFYING AND AUTHORIZING THE EXPENDITURE OF FY 14-15 FUNDS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, city staff identified a need to immediately replace inoperative air conditioning units on three City buses, and inoperative engines on two City buses; and

WHEREAS, the City Manager acted without delay, using emergency powers authorized under Section 2-797(2) of the City's Code of Ordinances, to procure sole-source OEM parts from Gillig, LLC and Cummins Power South, so that repairs could be completed in a timely manner before the commencement of a series of major public events at the end of October; and

WHEREAS, Section 2-797(2) of the City's Code of Ordinances requires the City Commission to ratify such emergency purchases at its next scheduled meeting.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: The City Commission, in accordance with Section 2-797(2) of the City of Key West Code of Ordinances, hereby ratifies the City Manager's emergency authorization for the procurement in the total amount of \$64,839.71 (\$19,999.98 to Gillig, LLC and \$44,839.73 to Cummins Power South) for the purchase of three bus air conditioning compressors from Gillig, LLC, and two bus engines from Cummins Power South.

Section 2: That the expenditure of funds from KWDOT Budget, as set forth in the attached memorandum is authorized and ratified.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
