Topic ORIGINAL

On 9-6-15 at 1413 hours, Key West Dispatch did an emergency tone out to all patrol officers reference a burglary which had just occurred at 1421 White Street.

I (Officer Ka. Wanciak) arrived at this location at 1413 hours and saw a Hispanic female (later identified by her FL. DL. as Janet Hernandez Delgado, VICTIM) running west across White Street holding a 9" butcher knife in her right hand yelling that the suspect left running west on Von Phister.

I aired a BOLO for the suspect, (later identified as Johnathan Altman, DEF) skinny, light skin, white male, blonde hair, blue shorts, no shirt running west on Von Phister.

Janet said she and her husband Dagoberto Delgado were invited to use the house at 1421 White Street by the owner Timothy Root for a birthday party today. Janet said when they arrived they heard noises in the house and knew someone was inside the home. Janet said they looked inside the window and saw several subjects inside the house. Janet said they called Timothy to make sure there was no one staying at the house. Janet said Timothy told her he did not give permission for anyone else to be at the house.

Janet said she and Dagoberto got the house key from the lock box outside and opened the front door. Janet said DEF was standing inside the door. Janet said she asked who he was with no reply. Janet said she asked DEF if he knew the owner of the house and DEF responded, "We sneaked in and we were just cooking." Janet said she grabbed a butcher knife from the kitchen and she held him down. Dispatch advised that a group of teenagers had broken into the house at this address. He requested that responding officers set up a perimeter in the area and, upon my arrival at the intersection of Reynolds St and Washington St, I stopped and maintained that corner.</p>	
	<p>Ofc O'Connell advised that one of the subjects was a black male wearing a white long-sleeved shirt, white pants, carrying a green bag. After several minutes, Ofc O'Connell arrived at my location and asked me to search the area in my car. While searching the surrounding neighborhoods, Sgt Wood advised over the radio that at house number 1023 on the street south of Flagler (Johnson St), he saw a person hiding on the roof. Ofcs O'Connell, Chaustit and I responded to the area and, upon our arrival, Sgt Wood directed my attention to a roof above what appeared to be a screened-in conservatory on the east side of the building. I saw a blond male (later identified as John ALTMAN) lying on the roof, oriented east-west. He looked up and, seeing us, started to stand up. We ordered him to get off the roof and he walked to the south side of the roof and smiled. He then jumped off the roof and when he landed, he stumbled. We gave him loud, repetitive verbal commands to get on the ground and he started running west along the side of the house. With my Taser pointed at him, I ran toward him, telling him to get on the ground. He looked over at me and, seeing the Taser pointed at him, he surrendered, by lying on the ground on his back. Ofcs Chaustit and O'Connell then turned him over and handcuffed his right hand. He still had his left hand tucked under his shoulder and would not obey commands to put it behind his back. Ofc Chaustit, using his Taser device, drive-stunned ALTMAN in his back, between the shoulder-blades, continuing to order him to put his hands behind his back. ALTMAN mentioned that he was being Tasered and Ofc Chaustit told him that if he complied, the Taser would stop. ALTMAN then complied and Ofc Chaustit stopped the Taser cycle. Once he had put his hands behind his back and he was handcuffed, he was sat up on the lawn.</p> <p>Soon after, Ofc Sims brought witnesses separately to the scene twice in order to conduct a show-up. On both occasions, Ofc Sims advised that the witnesses had positively identified ALTMAN. Sgt Wood read ALTMAN his Miranda Warning from a card that I provided him and ALTMAN said that he did not wish to answer any questions. As we stood there awaiting direction from Detective Mitchell whom Sgt Wood had summoned, ALTMAN made the spontaneous utterance, "Did we all get got?". I am unsure what the exact location was. Since I was still at 1421 White St. I made arrangements with the units on Johnson St. to do a show up with the subject they had detained.
		First, I drove Janet to Johnson St. As we neared the location where the suspect was, Janet said it was him. The suspect was sitting on the ground and looking away from her, and she was still able to make a positive ID. I went back and picked up Dagoberto. Dagoberto did the same thing as Janet. He positively ID the suspect, while the suspect was seated and looking away.
	Back at 1421 White St., I had Janet and Dagoberto write sworn statements. Each of them had to dictate their statements to a friend. Ofc. KA Wanciak has the information for the persons that wrote the statements. I swore them to the statements. Ofc. Wanciak took the statements for her report.

	1	On September 6, 2015, I responded to 1421 White Street in reference to an in progress burglary.
		I arrived and met with Ofc. Simms who advised there may still be a suspect inside the residence. Ofc. Sims, Ofc. Malgrat, and I entered the residence and searched the interior of the residence for any suspects. We cleared the residence and did not find anyone hiding inside the residence. We cleared the remaining structures that were not affixed to the residence and did not find anyone.
		Next Sgt. Wood requested assistance on Johnson Street and advised he saw one of the suspects. I arrived in the area and Sgt Wood advised the suspect was on the roof of the residence. Ofc. Oconnell , Ofc. Stevens, and I saw the suspect and ordered him off of the roof. The suspect, a white male with light blond hair, blue shorts, and no shirt came down from the roof and began to run. Ofc. Oconnell , Ofc. Stevens, and I advanced toward the suspect giving him no where to run. We all gave the suspect loud verbal commands to stop and get on the ground. The suspect continued to run. I yelled Tase him, Tase him! The suspect yelled don't Tase me and went to the ground lying on his back. Ofc. Oconnell and I gave him loud verbal commands to roll over and place his hands behind his back. The suspect did not comply with our lawful commands. Ofc. Oconnell and I rolled the suspect into the prone position and ordered him to put his hands behind his back. The suspect did not comply with our lawful commands. Ofc. Oconnell was able to gain control of the suspect's right hand and cuff his right wrist. The suspect held his left arm under his body and tensed his arm to prevent us from handcuffing him. I placed my Taser (with the cartridge removed) in between the suspect's shoulder blades and ordered him to put his arm behind his back. The suspect still refused. I activated my Taser and administered a drive stun. I ordered the suspect to place his hand behind his back. The suspect said I was Tasing him. I told the suspect as soon as he placed his hand behind his back it would stop. The suspect immediately placed his hand behind his back and I stopped the drive stun as soon as he complied with my lawful command. Ofc. Oconnell handcuffed the suspect and I instructed him to roll to his side and sit up.
		I advised Sgt. Wood I had used my Taser to drive stun the suspect. Ofc. Stevens and Sgt. Wood remained with the suspect. I left the scene and searched the surrounding area for the additional suspects. I was unable to locate any additional suspects from this incident.
