gainfully employed by the victim. The victim told the defendant multiple times to leave. The defendant refused to do so. The defendant refused to leave the structure at the request of law enforcement as well.

The defendant, Alexey Ozerov, did knowingly intentionally and unlawfully resist the victim, Ofc. Carter Sims and Ofc. Monica Young of the Key West Police Department. At the time, Ofc. C. Sims and Ofc. M. Young, were engaged in the lawful execution of their duty. At the time, Ofc. C. Sims and Ofc. M. Young were acting in the capacity as law enforcement officers gainfully employed by the Key West Police Department. At the time, the defendant knew Ofc. C. Sims and Ofc. M. Young were police officers, as they were dressed in their KWPD Class B Uniform. Ofc. C. Sims and Ofc. M. Young were attempting to remove the defendant for a trespassing offense.

On 09.28.15 at approximately 1443 hours, I, Ofc. Carter Sims, was dispatched to 3920 S. Roosevelt Blvd. N313 of Oceanwalk Apartments. This was in reference to two trespassers in the apartment who were refusing to leave, destroying the apartment, and drinking booze. Ofc. Monica Young was dispatched to the call as well, and I arrived moments after she did.

As I got out of my car, I looked up toward the third floor, and could see two males leaning against the railing. These males said they were the ones who had called about the subjects in the apartment. One of the males and victim in this case, Jason Keiper DOB 11.28.75, was later identified by his Florida driver's license. The second male and witness in this case, Matias Balleza DOB 10.12.81, was later identified by verbal information. Jason and Matias's identification was verified using law enforcement resources.

Jason identified himself as the Project Manager for Frazee Inc. and manager for their employee housing. Jason said Frazee Inc. had been hired to do construction work on the newly renovated hotels along the N. Roosevelt Blvd. corridor. Frazee Inc. had made arrangements with Oceanwalk Apartments to rent apartments so they could house their employees while working in Key West. Part of Jason's responsibilities was to oversee the employee housing. Jason has the authority to say who can stay in Frazee's employee workforce housing and who cannot stay.

Jason said one of Frazee's employees showed up to the work site this morning intoxicated, belligerent, and wanting to fight other workers. Jason said this employee was terminated immediately and told he had to vacate the apartment at Oceanwalk. Jason said the employee was in the apartment N313 with another male, and that both of them were refusing to leave after being told to do so. Jason gave Ofc. Young and I permission to enter the apartment.

Ofc. M. Young and I first tried knocking on the door and did not receive a response from inside. Ofc. M. Young turned the knob on the door and it was unlocked. As we stood at the door, we could hear loud music coming from inside. We opened the door and called out "Key West Police," a couple of times and did not receive a response. We continued in the apartment and encountered two white males sitting in the dining room area at a table. The employee who had been terminated and still in the apartment was later identified as, Alexey Ozerov DOB 06.07.73, by his Resident Alien Card. I recognized Alexey from previous law enforcement encounters. I did not get the reporting information for the other male.

Alexey questioned why we were in the apartment, but when we asked a question, he pretended not to speak English. He did say it was his friends birthday. As Alexey and the other male sat, they slumped in the chairs, and their chins were almost resting on their chest. At times, each of them had difficulty holding their heads up. I could see several cardboard beer boxes strewn about the floor. The apartment smelled of cigarette smoke and stale beer.

Alexey and his friend each smelled strongly of alcohol and showed signs of impairment. Each of them had slow and slurred speech, eyes were bloodshot and glassy, and their gross motor functions were slow and drawn out. Ofc. M. Young and I explained to Alexey he was not allowed to be in the apartment according to Jason, and that he needed to gather his belongings and leave. Alexey would ask what we were saying, and we would explain the same thing again. In the past when I have dealt with Alexey, he spoke limited English and could carry on a basic conversation. The friend understood he needed to leave, gathered some belongings, and was escorted out of the apartment.

Alexey sat in his chair and would not get up. He told Ofc. M. Young and I he was not going to leave, because he did not have to. Again, we told him to leave. At this time, I was standing behind him and Ofc. M. Young was standing in front of him. Alexey progressively became more agitated in his negative response. I began to gently push him on his upper back, in an attempt to get his body moving forward. He would tell me to stop and leave him alone.

As Ofc. M. Young stood in front of Alexey, she had her TASER out and told him he would be TASED if he did not move. I could see Alexey move his arms out to the side and begin to flex his muscles, as if he was preparing to fight. I stepped to his left and attempted to grab his left arm, so I could put him in a basic escort position, by making him stand. Alexey said something about not getting up or going, and withdrew both hands to his torso, crossing them, and clenching them tight.

I stepped back behind Alexey and took out my TASER, removed the cartridge, and told Alexey he would be TASED if he did not stop resisting our efforts. Again, Alexey said something about not doing it. Ofc. M. Young still had her TASER out. Using my left hand, I grabbed Alexey's left shoulder, and with the TASER in my right hand, I pressed it against his lower right back. Again, I gave him the opportunity to get up and he refused.

I pulled the trigger on the TASER initiating a five second cycle. Alexey's arms spread out a little bit and he began to rise out of the chair as I continued to hold the TASER to his lower back. Alexey came to a semi-standing position and fell over onto the ground, onto his hands and knees. The TASER lost contact with his back and I had to step over the chair in order to make contact a second time. AS I made contact with his upper right back, Alexey rolled over onto his back. I was standing over him and held the TASER against his upper torso. I gave him a command to roll over onto his back, and he did not comply. I initiated another five second cycle. Alexey immediately rolled over onto his stomach and quickly put his hands behind his head. I told him to put them behind his back and he did not comply. however, Ofc. M. Young was able to step in and handcuff him without further incident.

Alexey demonstrated the following Subject Resistance: Level 2- he made physically evasive movements to defeat my attempts at control. This was done by physically pulling his arms and hands in toward his chest as I tried to arrest him, and he refused to roll over and put his hands behind his back.

I responded to Alexey's resistance by using Officer Response Level 1: Physical Control- Pain Compliance by using the TASER in the drive stun mode only with the cartridge removed.

After Alexey was handcuffed and double-locked, he was escorted downstairs to await evaluation by Key West Fire Rescue. In addition, Sgt. H. Wood was notified of the incident and responded to Oceanwalk. Key West Fire Rescue #1 arrived on scene and evaluated Alexey. Alexey did not require further treatment. Sgt. H. Wood was briefed on what had occurred.

Alexey was placed in the back of my car and prepared for transport to the jail. I asked Ofc. M. Young to obtain sworn statements from Jason and Matias, which she did. See Ofc. M. Young's supplemental report for additional information and the statements from Jason and Matias. As I drove out of the Oceanwalk Apartment complex, Alexey would periodically yell out of the window.

At the jail, I told Alexey I needed to take pictures of the signature marks from when I used the TASER on him. He told me he would not allow me to take pictures. He stood up and began to walk off. He was told many times to sit down and he eventually complied. The MCSO Intake supervisor help me get photos of Alexey. Alexey would only show his back. As I was taking the pictures, he reached and pulled his pants down, exposing his buttocks. Alexey laughed as he thought this act of defiance was funny. He would not allow me to take pictures of his chest. The pictures are needed for documentation purposes. The photographs I took will be placed onto two CD's. One CD will placed into property and evidence, and the other to Sgt. H. Wood for reporting purposes.

The second male and witness in this case, Matias Balleza DOB 10.12.81, was later identified by verbal information. Jason and Matias's identification was verified using law enforcement resources.

Jason identified himself as the Project Manager for Frazee Inc. and manager for their employee housing. Jason said Frazee Inc. had been hired to do construction work on the newly renovated hotels along the N. Roosevelt Blvd. corridor. Frazee Inc. had made arrangements with Oceanwalk Apartments to rent apartments so they could house their employees while working in Key West. Part of Jason's responsibilities was to oversee the employee housing. Jason has the authority to say who can stay in Frazee's employee workforce housing and who cannot stay.

Jason said one of Frazee's employees showed up to the work site this morning intoxicated, belligerent, and wanting to fight other workers. Jason said this employee was terminated immediately and told he had to vacate the apartment at Oceanwalk. Jason said the employee was in the apartment N313 with another male, and that both of them were refusing to leave after being told to do so. Jason gave Ofc. Young and I permission to enter the apartment.

Ofc. M. Young and I first tried knocking on the door and did not receive a response from inside. Ofc. M. Young turned the knob on the door and it was unlocked. As we stood at the door, we could hear loud music coming from inside. We opened the door and called out "Key West Police," a couple of times and did not receive a response. We continued in the apartment and encountered two white males sitting in the dining room area at a table. The employee who had been terminated and still in the apartment was later identified as, Alexey Ozerov DOB 06.07.73, by his Resident Alien Card. I recognized Alexey from previous law enforcement encounters. I did not get the reporting information for the other male.

Alexey questioned why we were in the apartment, but when we asked a question, he pretended not to speak English. He did say it was his friends birthday. As Alexey and the other male sat, they slumped in the chairs, and their chins were almost resting on their chest. At times, each of them had difficulty holding their heads up. I could see several cardboard beer boxes strewn about the floor. The apartment smelled of cigarette smoke and stale beer.

Alexey and his friend each smelled strongly of alcohol and showed signs of impairment. Each of them had slow and slurred speech, eyes were bloodshot and glassy, and their gross motor functions were slow and drawn out. Ofc. M. Young and I explained to Alexey he was not allowed to be in the apartment according to Jason, and that he needed to gather his belongings and leave. Alexey would ask what we were saying, and we would explain the same thing again. In the past when I have dealt with Alexey, he spoke limited English and could carry on a basic conversation. The friend understood he needed to leave, gathered some belongings, and was escorted out of the apartment.

During this time, Jason and Matias, were standing in the kitchen and were there to see everything that occurred and hear what was said.

Alexey sat in his chair and would not get up. He told Ofc. M. Young and I he was not going to leave, because he did not have to. Again, we told him to leave. At this time, I was standing behind him and Ofc. M. Young was standing in front of him. Alexey progressively became more agitated in his negative response. I began to gently push him on his upper back, in an attempt to get his body moving forward. He would tell me to stop and leave him alone.

As Ofc. M. Young stood in front of Alexey, she had her TASER out and told him he would be TASED if he did not move. I could see Alexey move his arms out to the side and begin to flex his muscles, as if

he was preparing to fight. I stepped to his left and attempted to grab his left arm, so I could put him in a basic escort position, by making him stand. Alexey said something about not getting up or going, and withdrew both hands to his torso, crossing them, and clenching them tight.

I stepped back behind Alexey and took out my TASER, removed the cartridge, and told Alexey he would be TASED if he did not stop resisting our efforts. Again, Alexey said something about not doing it. Ofc. M. Young still had her TASER out. Using my left hand, I grabbed Alexey's left shoulder, and with the TASER in my right hand, I pressed it against his lower right back. Again, I gave him the opportunity to get up and he refused.

I pulled the trigger on the TASER initiating a five second cycle. Alexey's arms spread out a little bit and he began to rise out of the chair as I continued to hold the TASER to his lower back. Alexey came to a semi-standing position and fell over onto the ground, onto his hands and knees. The TASER lost contact with his back and I had to step over the chair in order to make contact a second time. AS I made contact with his upper right back, Alexey rolled over onto his back. I was standing over him and held the TASER against his upper torso. I gave him a command to roll over onto his back, and he did not comply. I initiated another five second cycle. Alexey immediately rolled over onto his stomach and quickly put his hands behind his head. I told him to put them behind his back and he did not comply. however, Ofc. M. Young was able to step in and handcuff him without further incident.

Alexey demonstrated the following Subject Resistance: Level 2- he made physically evasive movements to defeat my attempts at control. This was done by physically pulling his arms and hands in toward his chest as I tried to arrest him, and he refused to roll over and put his hands behind his back. I responded to Alexey's resistance by using Officer Response Level 1: Physical Control- Pain Compliance by using the TASER in the drive stun mode only with the cartridge removed.

After Alexey was handcuffed and double-locked, he was escorted downstairs to await evaluation by Key West Fire Rescue. In addition, Sgt. H. Wood was notified of the incident and responded to Oceanwalk. Key West Fire Rescue #1 arrived on scene and evaluated Alexey. Alexey did not require further treatment. Sgt. H. Wood was briefed on what had occurred.

Alexey was placed in the back of my car and prepared for transport to the jail. I asked Ofc. M. Young to obtain sworn statements from Jason and Matias, which she did. See Ofc. M. Young's supplemental report for additional information and the statements from Jason and Matias. As I drove out of the Oceanwalk Apartment complex, Alexey would periodically yell out of the window.

At the jail, I told Alexey I needed to take pictures of the signature marks from when I used the TASER on him. He told me he would not allow me to take pictures. He stood up and began to walk off. He was told many times to sit down and he eventually complied. The MCSO Intake supervisor help me get photos of Alexey. Alexey would only show his back. As I was taking the pictures, he reached and pulled his pants down, exposing his buttocks. Alexey laughed as he thought this act of defiance was funny. He would not allow me to take pictures of his chest. The pictures are needed for documentation purposes. The photographs I took will be placed onto two CD's. One CD will placed into property and evidence, and the other to Sgt. H. Wood for reporting purposes.

The defendant, Alexey Ozerov, did knowingly intentionally and unlawfully remain in the structure, located at 3920 S. Roosevelt Blvd. N313, that was in the lawful possession of the victim, Jason Keiper.

On Monday, September 28, 2015 I (Ofc. M. Young), along with Ofc. C. Sims responded to Ocean Walk Apartments, 3920 S. Roosevelt Blvd, unit 313N in reference to two trespassers in the apartment.

Upon arrival, we were met by Jason Kriper, who stated that he is the project manager for a construction company and that a former employee is now trespassing in the apartment. Kriper stated that the employee was fired and given notice that he no longer can reside in the free employee housing. The employee who was later identified by his Permanent Residence Card as, Alexia Ozerroc, had been refusing to leave the apartment when requested by Kriper, and had also invited a friend into the apartment to sit inside and become intoxicated with him.

Ofc. Sims and I knocked on the door of the apartment and received no answer, we were authorized to enter the apartment by Kriper. As we entered the apartment, we announced ourselves as, "Key West Police" and received no answer, but could hear music playing in the main area. When entering into the living area, we made contact with Ozerroc and his friend, both sitting at a table, drinking Heineken beers. It was clear that both subjects were intoxicated due to their speech, blood shot, glassy eyes and empty beer bottles all around them.

Ofc. Sims and I explained to both subjects that they had to leave the property and were no longer allowed back or they would be subject to arrest. Ozerroc's friend got up and was escorted into the hallway with his belongings. This friends name was not recorded, as we were focusing on Ozerroc who was becoming increasingly difficult.

Ozerroc refused to leave the property or even get out of the chair when asked several times by myself and Ofc. Sims. Ozerroc would act like he could not understand and would say that he did not know why

we were there. I displayed my Taser, standing in front of Ozerroc and told him to stand up again. Ozerroc crossed his arms and legs, tensing up and was now physically displaying noncompliance of our lawful commands, as well as the verbal non compliance he had been displaying. Ofc. Sims took out his Taser and had a better vantage point standing behind Ozerroc. It was clear Ozerroc was escalating as he refused our lawful commands and Ofc. Sims, after several warnings, drive stunned Ozerroc on his back. Ozerroc went to the floor and was told to put his hands behind his back, in which he refused and a drive stun was applied a second time to his back, by Ofc. Sims. I was then able to secure both of Ozerroc's arms and handcuff him. Ozerroc was assisted in standing up and escorted downstairs to our patrol cars.

Ofc. Sims and I requested a supervisor and rescue to respond. Ozerroc did not appear to have sustained any injuries and was cleared by Rescue 3.

Ofc. Sims transported Ozerroc to the Monroe County Jail and I obtained witness statements from Kriper and another employee who both witnessed our encounter with Ozerroc. I provided copies to Sgt. Wood and put the originals in the Records mailbox.

I also had dispatch enter in a trespass warning for Ozerroc for Ocean Walk Apartments, 313N.
