On 09/02/15 at approximately 0024 hours, I (Ofc. Fraga) was dispatched to 5th Street and North Roosevelt Blvd. reference a hit and run traffic accident with injuries (KWPD CASE # 15-401399) Due to the distance I was from the accident scene, I went looking for the suspect vehicle. Dispatch advised the vehicle was silver in color and had a broken windshield.

I turned on my blue overhead lights and activated my siren. The vehicle pulled into the turning lane at Flagler Ave. and 14th Street, stopped, and continued driving North on 14th Street. I followed behind the vehicle for about 1300 Feet with my blue lights on and using my siren. The Kia finally drove over a sidewalk and headed towards the office building at Stadium Mobile Home Park. I exited my vehicle and ran to the driver side of the Kia. I ordered the driver, later identified as Ramon Mendoza out of his vehicle. Mendoza did not have the vehicle in park, when he exited, his vehicle crashed into a wooden railing causing minor damage.

I ordered Mendoza to get on the ground. I had my X26P Taser pointed at Mendoza. Mendoza walked towards me slowly and after several verbal commands to "get on the ground," Mendoza began to lay on the ground belly first. Mendoza then jumped up and begin running. I activated my Taser and struck Mendoza in the left forearm and bicep. The Taser ran for one cycle (5 seconds) and caused NMI (Neuromuscular Incapacitation) causing Mendoza to fall to the ground.

Ofc. Leahy arrived on scene shortly after and detained Mendoza while he was on the ground. Mendoza was assisted off the ground and KWFD Rescue was called to the scene to remove probes and evaluate Mendoza. While standing next to Mendoza I could smell a strong odor of alcohol coming from his person. After Mendoza was evaluated he was placed into the rear of my patrol vehicle. A check in F/NCIC revealed Mendoza does not have a license. Mendoza was subsequently arrested on other charges (KWPD CASE# 15-401399).

I transported Mendoza to the Monroe County Detention Center without incident. My COBAN was running during the incident. My BWC was activated shortly after Mendoza was tased.

CASE STATUS: CLEARED BY ARREST

Mendoza is charged with FSS 316.1935 (2), Flee and Elude with lights and sirens. Mendoza failed to stop his vehicle when I attempted to stop him with my KWPD marked patrol car, blue overhead lights and my siren activated.

Mendoza is charged with FSS 843.02, Resisting Officer without violence. Mendoza was given a lawful order to get on the ground. Mendoza instead jumped up and begin to run away.

Mendoza is charged with FSS 322.03 (1) Driving without a license. Through a check in F/NCIC it was determined Mendoza never had a license.

shattered windshield driving East on Flagler. The vehicle had an abundant amount of front end damage and was smoking as well. I made a U-Turn at Kennedy Drive and got behind the silver vehicle. The vehicle was a Hyundai Accent bearing Arkansas tag 026WSR.

I turned on my blue overhead lights and activated my siren. The vehicle pulled into the turning lane at Flagler Ave. and 14th Street, stopped, and continued driving North on 14th Street. I followed behind the vehicle for about 1300 Feet with my blue lights on and using my siren. The Kia finally drove over a sidewalk and headed towards the office building at Stadium Mobile Home Park. I exited my vehicle and ran to the driver side of the Kia. I ordered the driver, later identified as Ramon Mendoza out of his vehicle. Mendoza did not have the vehicle in park, when he exited, his vehicle crashed into a wooden railing causing minor damage.

I ordered Mendoza to get on the ground. I had my X26P Taser pointed at Mendoza. Mendoza walked towards me slowly and after several verbal commands to "get on the ground," Mendoza began to lay on the ground belly first. Mendoza then jumped up and begin running. I activated my Taser and struck Mendoza in the left forearm and bicep. The Taser ran for one cycle (5 seconds) and caused NMI (Neuromuscular Incapacitation) causing Mendoza to fall to the ground.

Ofc. Leahy arrived on scene shortly after and detained Mendoza while he was on the ground. Mendoza was assisted off the ground and KWFD Rescue was called to the scene to remove probes and evaluate Mendoza. While standing next to Mendoza I could smell a strong odor of alcohol coming from his person. After Mendoza was evaluated he was placed into the rear of my patrol vehicle. A check in F/NCIC revealed Mendoza does not have a license. Mendoza was subsequently arrested on other charges (KWPD CASE# 15-401399).

I transported Mendoza to the Monroe County Detention Center without incident. My COBAN was running during the incident. My BWC was activated shortly after Mendoza was tased.

On 09/02/2015, at approximately 0023 hours, I, Ofc. Leahy assisted in the apprehension of a suspect who had committed a hit and run at the intersection of 5th St. and N. Roosevelt Blvd.

Total Recovered Property Value: \$0.00

I heard Ofc. Fraga advise, he was behind the suspect vehicle, on 14th St., traveling towards Northside Dr. I heard Ofc. Fraga say, he had one subject at "TASER" point. I heard Ofc. Fraga say, he had deployed his "TASER."

I arrived on scene moments after Ofc. Fraga's radio traffic. I saw Ofc. Fraga standing near a male subject who was lying on his back. I exited my patrol vehicle and approached the suspect, later identified by his foreign ID card as Roman Mendoza-Zapata (Arrestee). I handcuffed (double locked) Mendoza-Zapata and placed him into custody.

I donned my personal protective gloves and removed one of the "TASER" probes which was lodged in the upper, inside area of Mendoza-Zapata's left arm. I saw the other probe was lodged in the lower inside area of Mendoza-Zapata's left arm. The probe appeared to be lodged deeper in the arm, so I thought it was best to wait for Key West Rescue 3, and have them remove the probe.

I conducted as search of Mendoza-Zapata's person. I recovered a wallet, cell phone and US currency from Mendoza-Zapata's person. I subsequently handed the items over to Ofc. Fraga.

Key West Rescue arrived on scene and removed the other "TASER" probe from Mendoza-Zapata's left arm.

I placed the "TASER" cartridge/probes into an evidence bag.

Ofc. Williams stood by with Mendoza-Zapata.

I had Ofc. Fraga place crime scene tape around the area, where Mendoza-Zapata has crashed his vehicle, at 1213 14th St.

Ofc. Fraga and I collected two "TASER" affids, which were placed in an evidence bag.

where he was later flown to Miami for treatment of his injuries.

I spoke with Marsello Billups, another witness, who said he was traveling East in the inside lane on N. Roosevelt Blvd. Billups said a gray car, later identified as a grey Hyundai Accent bearing Arkansas tag 026WSR, was traveling East on N. Roosevelt Blvd in the outside lane, behind Tovar on his scooter. Billups said he watched as the gray Hyundai struck Tovar from behind, in front of 2222 N. Roosevelt Blvd. (Yamaha). Billings said Tovar and his scooter began to flip down the road to their resting places. Billups said the gray Hyundai fled then the area. Billups said he told a motorcycle with two passengers, that had arrived shortly after, to follow gray Hyundai. I obtained a sworn written statement from Billups and placed it in the Key West Police Records Section.

I spoke with Vach who said he was riding his bicycle on the sidewalk along the North side of N. Roosevelt Blvd. Vach was not able to describe the gray Hyndaui very well but said he may have seen a white van. Vach said he saw Tovar get hit from behind by the other vehicle and Tovar went tumbling down the street with his scooter. Vach said the other vehicle did not stop.

I spoke with Smidt who did not witness the crash but was on scene helping Tovar until emergency services arrived.

Angela Gonzalez and Danielle Robinson, who were not on scene when I arrived and did not witness the crash. Gonzalez and Robinson said they arrived after the crash but saw the gray Hyundai fleeing form the area when they began following it. Gonzalez and Robinson tried to follow the vehicle South on 7th St but eventually lost him in that area..

With the descriptions and direction of travel provided to Key West Police Dispatch by all witnesses, Officer D. Fraga located the gray Hyundai bearing Arkansas tag 026WSR by 3100 Flagler Ave. (Habana Plaza). Ofc. Fraga attempted to stop the gray Hyundai but it fled and went North on 14th St. Ofc. Fraga was able to get the vehicle stopped at 1213 14th St., after crashed into a building, where he was able to identify the driver as Ramon Mendoza-Zapata. Mendoza-Zapata did not have a valid license and after checking him through the Florida Department of Highway Safety and Motor Vehicles (DAVID) and F/NCIC we learned he has never been issued a license.

I cited (A3DK0RE) Mendoza-Zapata for Leaving the Scene of a Crash Involving Serious Injury, a violation of F.S.S. 316.027(1)(a).

I cited (A3DK0SE) Mendoza-Zapata for Driving Without a License Causing Serious Injury with Vehicle, a violation of F.S.S. 322.034.

I cited (A3DK0TE) Mendoza-Zapata for Leaving the Scene of a Crash Involving Property Damage, a violation of F.S.S. 316.061(1).

Mendoza-Zapata was arrested by Ofc. Fraga for other charges and transported to the Monroe County Detention Center without incident. I met Ofc. Fraga at the Monroe County Detention Center where I also arrested Mendoza-Zapata for the above charges.

Upon arrival, I saw a male I identified as Juan Tovar in the street bleeding from his head and face. Tovar was being assisted into a seated positron by Darren Smidt and Stephen Vach (witnesses). KWFD Rescue arrived on scene and transported Tovar to Lower Keys Medical Center, where he was later flown to Miami for treatment of his injuries.

While on scene Marsello Billups arrived and identified himself as a witness. Billiups said he was traveling East in the inside lane on N. Roosevelt Blvd. Billups said a gray car, later identified as a grey Hyundai Accent bearing Arkansas tag 026WSR, was traveling East on N. Roosevelt Blvd in the outside lane, behind Tovar on his scooter. Billups said he watched as the gray Hyundai struck Tovar from behind, in front of 2222 N. Roosevelt Blvd. (Yamaha). Billings said Tovar and his scooter began to flip down the road to their resting places. Billups said the gray Hyundai fled then the area. Billups said he told a motorcycle with two passengers, that had arrived shortly after, to follow gray Hyundai. obtained a sworn written statement from Billups and placed it in the Key West Police Records Section.

I spoke with Vach who said he was riding his bicycle on the sidewalk along the North side of N. Roosevelt Blvd. Vach was not able to describe the gray Hyndaui very well but said he may have seen a white van. Vach said he saw Tovar get hit from behind by the other vehicle and Tovar went tumbling down the street with his scooter. Vach said the other vehicle did not stop.

I spoke with Smidt who did not witness the crash but was on scene helping Tovar until emergency services arrived.

While on scene Angela Gonzalez and Danielle Robinson arirved and said they did not witness the crash but arrived right after crash had occured. Gonzalez and Robinson said they saw the gray Hyundai fleeing from the area when they began following it. Gonzalez and Robinson tried to follow the vehicle South on 7th St but eventually lost him in that area..

With the descriptions and direction of travel provided to Key West Police Dispatch by all witnesses, Officer D. Fraga located the gray Hyundai bearing Arkansas tag 026WSR by 3100 Flagler Ave. (Habana Plaza). Ofc. Fraga attempted to stop the gray Hyundai but it fled North on 14th St. Ofc. Fraga was able to get the vehicle stopped at 1213 14th St., after crashing into a building (see case #15-401400), where he was able to identify the driver as Ramon Mendoza-Zapata. Mendoza-Zapata did not have a valid license and after checking him through the Florida Department of Highway Safety and Motor Vehicles (DAVID) and F/NCIC we learned he has never been issued a license.

I cited (A3DK0RE) Mendoza-Zapata for Leaving the Scene of a Crash Involving Serious Injury, a violation of F.S.S. 316.027(1)(a).

I cited (A3DK0SE) Mendoza-Zapata for Driving Without a License Causing Serious Injury with Vehicle, a violation of F.S.S. 322.034.

On 09/02/2015, at approximately 0023 hours, I, Ofc. C. Rhinhart responded and assisted Ofc. D. Fraga at 1213 Glynn R. Archer Jr. Dr., regarding the apprehension of a hit and run suspect and crash investigation.

I heard Ofc. Fraga advise, he was behind the suspect vehicle, on 14th St., traveling towards Northside Dr. I heard Ofc. Fraga say, he had one subject at "TASER" point. I heard Ofc. Fraga say, he had deployed his "TASER."

Upon my arrival on scene, I blocked the roadway with my Key West Police cruiser to prevent further unnecessary traffic from entering the crash/crime scene area.

I obtained witness information from (Witness) Angela M. Gonzalez and (Witness) Danielle D. Robinson.

Gonzalez and Robinson stated they observed the suspect vehicle leave the crash scene at N. Roosevelt Blvd. and 5th St. outbound on N. Roosevelt Blvd. Gonzalez and Robinson said the suspect vehicle turned left onto 7th St. Gonzalez stated they attempted to follow the suspect vehicle with obvious substantial damage in an attempt to notify Law Enforcement. Gonzalez advised she lost track of the suspect vehicle on 7th St.

Gonzalez stated she saw police lights on 14th St. and noticed the suspect vehicle that she was previously following. Gonzalez and Robinson said they wanted to report what they observed at the crash scene at N. Roosevelt Blvd. and 5th St.

SUPPLEMENTAL

On September 2nd, 2015 at approximately 0023 hours, dispatch advised that a hit and run with injuries had just occurred. The suspect vehicle was possibly a gray sedan with a shattered windshield. I drove the Flagler Ave route from White St. Officer Fraga advised he was behind the possible suspect vehicle. Officer Fraga then advised the driver was fleeing in front of Stadium Trailer Park. Officer Fraga advised he had the driver Taser point and then Taser deployed. I was on scene a short time after Taser deployment. I observed Ofc. Fraga with Taser deployed and Ofc. Leahy securing the suspect on the ground. I assisted securing the suspect, later identified to be Ramon Zapata. Ramon spoke little English therefore, I translated English to Spanish during most of the interaction with Ramon. I translated to the best of my abilities.

Ramon made spontaneous utterances prior to him being questioned on a crash and dui investigation. Ramon said the following: We (police) did not know how bad he had it and all the problems he has to deal with. This (incident) is going to affect him in getting his legal paperwork in this country. This (incident) was going to affect is kids. He asked where his car was and I pointed to car.

Ramon reported that he was not injured or in pain. Ramon complained of handcuff discomfort. I checked the handcuffs 3 times and they were applied loose. Ramon got cleared by rescue. Ramon had a strong odor of an alcoholic beverage emanating from his person. Ramon could not maintain his balance while standing or walking. Ramon's eyes were bloodshot and glassy. Ramon's speech was slurred and many times inarticulate.

Officer Keohane arrived on scene and I translated for her. I read Ramon Miranda Warnings in Spanish from a Miranda cue card. Ramon understood his rights and waived Miranda. The following is a summary of the interview between Ofc. Keohane and Ramon that I translated to the best of my abilities:

Ramon left work and went to Bare Assests with friends. He was on his way home to Stock Island after he left Bare Assests. He was driving and no one else was in the car with him. He denied knowing anything about a crash involving him. He denied knowing how his car obtained a shattered windshield or how he obtained broken glass particles on his clothing.

Officer Keohane stepped away from Ramon, while I remained in his presence. Ramon began crying

and began talking to me without being questioned. Ramon commented on him not seeing his family in Honduras for over 9 years therefore, he did not care if he got deported because if he did, he could see his family again. Ramon commented on him knowing why he was there (meaning in the moment) and it was because he crashed. Ramon then told me he could have run away but he didn't. I asked Ramon why he began to run and I asked him if it was due to fear. Ramon said he ran because he was "in part" afraid. I asked Ramon if he was wearing his seatbelt and he said he was.

Through Ofc. Keohane, I informed Ramon that the crash investigation was complete and that he was being investigated for potentially driving under the influence. I asked Ramon if he was willing to do FSE and he consented. Ramon stated he did not have any medical ailments that would prevent him doing the FSE. I translated the HGN exercise. I observed both obvious HGN and VGN. I translated the Walk n Turn exercise. Initially Ramon attempted the Walk n Turn but missed many ques. Ramon stopped and said he could not do it because he had been drinking. I translated the One Leg Stand exercise. Ramon missed many ques. Ramon stopped and said he could not do the exercise.

I read the request for Blood Draw in Spanish from a cue card. Ramon consented to a blood draw. I notified Ramon of the criminal charges he was arrested for.

No further action or involvement on my behalf. My COBAN and Body Cam captured the investigation.
