A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RENEWING THE ATTACHED "AGREEMENT" FOR EMS BILLING BETWEEN THE CITY OF KEY WEST AND AMBULANCE MEDICAL BILLING (AMB), A SUBDIVISION OF CREDIT BUREAU SYSTEMS, INC. (CBS) FOR A PERIOD OF ONE YEAR; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 14-347, the City Commission awarded the bid to Ambulance Billing Services in response to RFQ No. 002-15 for EMS Billing Services; and

WHEREAS, City staff recommends approval of a one-year renewal (the first of up to three renewals), pursuant to section 6.1 of the Agreement;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That a one-year renewal of the attached "Agreement" between the City of Key West and Ambulance Medical Billing for EMS Billing Services is hereby approved.

Section 2: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
