this time Ofc. Bouvier and Ofc. Andruzzi arrived in the area of GFS. They were able to locate the suspect and attempted to gain custody of him. Ofc. Bouvier stated that the suspect had run into the pool area near the Fairfield Inn. There was then a foot chase involving Ofc. Bouvier and Ofc. Andruzzi. Ofc. Andruzzi then stated that the suspect who was later identified as, Emilio Jose Martinez, was in custody across from the NAPA.

I spoke with Ofc. Andruzzi and Ofc. Bouvier. They both explained to me that Martinez would not stop for them as they chased them. Both of them were driving marked patrol cars when they arrived on scene and were wearing Key West Police Department issued uniforms. There was no doubt in their minds that Martinez was aware that he was being chased and ordered to stop by the police. Ofc. Bouvier deployed his Taser as Martinez ran from him. Ofc. Andruzzi used his expandable baton to try to affect an arrest on Martinez. Ofc. Andruzzi and Ofc. Bouvier have both written supplemental reports as to their interaction with Martinez. I was not on scene when Ofc. Bouvier and Ofc. Andruzzi interacted with Martinez.

When I arrived on scene Martinez was already in custody. I approached him and read him his Miranda Warnings. He stated to me that he understood and wished to speak to a lawyer.

After further investigation I was informed by Ofc. Blanco that no one at Winn Dixie had been punched. However, Martinez did attempt to steel three twelve packs of beer totaling \$55.97. Martinez walked past the last point of purchase with no attempt to pay for the beer. He was confronted by Winn Dixie management. A disturbance occurred and Martinez ran from the area. Winn Dixie stated they wanted to press charges for Retail Theft.

l obtained three written statements in reference to the Retail Theft which were placed into the Key West police Departments record section. Winn Dixie management (Emelina McLosham) stated that they would check for video surveillance tomorrow when an operator arrived to work.

Rescue was requested to the scene for Martinez. Martinez stated he had no injuries and refused treatment by rescue when they arrived.

Emilio Martinez was placed under arrest for Retail Theft FSS 812.014(3)(a). He was also charged for Resisting an Officer without Violence FSS 843.02. He was transported to the MCDC without incident. My BWC was operational during this encounter. My in car COBAN was activated once Martinez was placed inside my patrol vehicle. No further information at this time.

On Friday October 9, 2015 at approximately 8:00pm, I, Ofc. K. Bouvier responded to 2760 N. Roosevelt Blvd. (Win-Dixie Supermarket) in reference to a call of a battery.

While I was enroute I was informed by Key West Police Communications Channel One (Comm One) that the suspect was running a way from the area.

The suspect was later identified as Emilio Martinez.

Ofc. M. Andruzi spotted Mr. Martinez on 7th Street next to the Fair Field Inn. Mr. Martinez then ran onto the hotel property. Ofc. M. Andruzzi followed Mr. Martinez into the pool area of the hotel while I ran to the front of the property anticipating Martinez would exit onto N. Roosevelt Blvd. Mr. Martinez did exit the hotel property onto N. Roosevelt when I saw Mr. Martinez I ordered him to stop running. Mr. Martinez ignored my instructions and continued to run. I fire my Key West Police Department issued Taser at Mr. Martinez, only one probe from the Taser connected and as a result the Taser had no effect.

While I was attempting to holster the Taser and maintain pursuit of Mr. Martinez I lost my footing and fell into the roadway. As I recovered and continued the foot pursuit I was unaware that I had not secured the Taser.

After a short time later Mr. Martinez was taken into custody.

Once Mr. Martinez was secured, I did an equipment check of my person, ensuring I hadn't lost the body-cam, COBAN mic, my cellular phone or any other equipment as a result of my fall. It was at this moment I realized that I must have dropped the Taser during the fall.

Ofc. D. Blanco and I met with the manager of Win-Dixie who said that Mr. Martinez did not strike her intentionally. The manager said she would provide a disk with security footage of Mr. Martinez stealing beer from the store.

I placed the spent Taser cartridge into the Key West Police Property Division as evidence.

My KWPD issued body-cam and my COBAN system were both activated during this call.

Topic **ORIGINAL**

On October 9, 2015 at approximately 2005 hours, I (Ofc. Gaufillet), responded to a 911 hang up, at the Winn Dixie.

As I was heading to the scene, dispatch stated that this was in fact going to be a physical disturbance between a white male and the store manager. Moments later dispatch stated that the suspect was now running inbound on North Roosevelt Blvd. He was reported to be a white male, 45 years of age, wearing a white shirt, no shoes and pink shorts. Dispatch then reported that the suspect was in the area of GFS. At about this time Ofc. Bouvier and Ofc. Andruzzi arrived in the area of GFS. They were able to locate the suspect and attempted to gain custody of him. Ofc. Bouvier stated that the suspect had run into the pool area near the Fairfield Inn. There was then a foot chase involving Ofc. Bouvier and Ofc. Andruzzi. Ofc. Andruzzi then stated that the suspect who was later identified as, Emilio Jose Martinez, was in custody across from the NAPA.

I spoke with Ofc. Andruzzi and Ofc. Bouvier. They both explained to me that Martinez would not stop for them as they chased them. Both of them were driving marked patrol cars when they arrived on scene and were wearing Key West Police Department issued uniforms. There was no doubt in their minds that Martinez was aware that he was being chased and ordered to stop by the police. Ofc. Bouvier deployed his Taser as Martinez ran from him. Ofc. Andruzzi used his expandable baton to try to affect an arrest on Martinez. Ofc. Andruzzi and Ofc. Bouvier have both written supplemental reports as to their interaction with Martinez. I was not on scene when Ofc. Bouvier and Ofc. Andruzzi interacted with Martinez.

When I arrived on scene Martinez was already in custody. I approached him and read him his Miranda Warnings. He stated to me that he understood and wished to speak to a lawyer.

After further investigation I was informed by Ofc. Blanco that no one at Winn Dixie had been punched. However, Martinez did attempt to steel three twelve packs of beer totaling \$55.97. Martinez walked past the last point of purchase with no attempt to pay for the beer. He was confronted by Winn Dixie management. A disturbance occurred and Martinez ran from the area. Winn Dixie stated they wanted to press charges for Retail Theft.

I obtained three written statements in reference to the Retail Theft which were placed into the Key West police Departments record section. Winn Dixie management (Emelina McLosham) stated that they would check for video surveillance tomorrow when an operator arrived to work.

Rescue was requested to the scene to check on Martinez. He stated he had no injuries and refused treatment.

Emilio Martinez was placed under arrest for Retail Theft FSS 812.014(3)(a). He was also charged for Resisting an Officer without Violence FSS 843.02. He was transported to the MCDC without incident. My BWC was operational during this encounter. My in car COBAN was activated once Martinez was placed inside my patrol vehicle. No further information at this time.

This report should be read in conjunction with all other reports under this case number.

On 10/09/2015 at approx. 2005 hours I (Officer Andruzzi) responded to a call at the Winn Dixie Store located at 2778 N. Roosevelt. Dispatch stated a white male with pink shorts and a white shirt punched the Winn Dixie Store Manager. As I was responding Key West Dispatch related the suspect was now running inbound on Roosevelt Blvd. and was approaching the GFS Store located on Roosevelt Blvd.

As I approached the corner of Seventh Street and Roosevelt I observed an individual matching the description of the suspect from the Winn Dixie Store. I was driving in a Key West marked police vehicle and wearing a Key West Police Department uniform. The subject, now known as Emilio Martinez, was running towards my police vehicle. As I stopped my vehicle Martinez ran around the back of it and continued running into the Fairfield Inn pool area. I exited my vehicle and gave chase on foot. Martinez exited the pool area and into the hotel parking lot. Martinez was confronted by Officer Bouvier who yelled Key West Police and told Martinez to stop. I observed Martinez run around Officer Bouvier. I observed Officer Bouvier deploy his taser at Martinez with negative results. Martinez continued to run out of the parking lot and across Roosevelt Blvd. I continued to chase Martinez on foot and told him several times to stop. Martinez refused to stop fleeing. As I ran behind Martinez I struck Martinez on the right hip with my expandable baton in an attempt to stop him from running. Martinez continued to run inbound Roosevelt Blvd. Martinez crossed Roosevelt Blvd. and came to a stop. As I approached Martinez I ordered him to the ground. Martinez got on the ground on his hands and knees. I ordered Martinez to the ground verbally and assisted him by pushing down on his back. Martinez was handcuffed and placed under arrest.

Martinez was transported to the Monroe County Jail by Officer Gaufillet for processing.

During the beginning of the foot pursuit I activated my BWC. After Martinez was secured I discovered my BWC was not flashing but the lens camera was in fact open. I attempted to download my BWC video to the Coban System and discovered no video recorded due to a malfunction.
