On Saturday, October 31, 2015, at approximately 0241 hours, Officer T. Clark and I. Officer J. Young were working an off duty detail in the 200 block of Duval St. when we observed two white males, Matthew StClair (Michigan DL) and Michael Sankowski exit the Lazy Gecko Bar physically fighting. StClair was actively attacking Sankowski with his hands and fists. Sankowski was not making attacking movements towards StClair and was attempting to stop StClair from striking him. Both StClair and Sankowski fell to the ground in the middle of the street.

Officer Clark grabbed a hold of Sankowski and I grabbed a hold of StClair in an attempt to separate them and stop the altercation. As I grabbed a hold of StClair's arm and he was actively getting to his feet and lunged towards Officer Clark, who had his back towards StClair. I interpreted this as a threat to Officer Clark's personal safety and I placed myself between them. StClair and I were face to face and he continued his attempt to attack Officer Clark by pushing me backwards and out of the way. I was able to gain my footing and stop StClair from gaining ground towards Officer Clark.

I pushed StClair backwards in an attempt to place some distance between us so I may engage StClair and place him in handcuffs. When I pushed StClair backwards, he lost his balance and fell backwards. StClair's hands landed in the water filled area of the gutter and curb where his left hand landed on a glass beer bottle. I heard the glass beer bottle break under StClair's hand.

StClair jumped back to his feet, charged towards me in an aggressive manner. I un holstered my TASER, pointed it at StClair and gave him loud verbal commands to stop. StClair complied with my verbal commands and stopped. I did not activate the power switch to the "On" position so no TASER video exists.

By this time several other officers arrived on scene and assisted with removing Sankowski from the scene. Officer Clark came behind StClair and while I had StClair's attention Officer Clark was able to place StClair into handcuffs.

As StClair was being placed into handcuffs, I saw he was bleeding heavily from his left hand had a large laceration to the outside of his hand. It was clear StClair was in need of medical attention for his wound and Lt. Tripp requested for Key West Fire / Rescue to respond to the scene.

With the crowd building around us we decided to move StClair and we escorted him towards Old City Hall on Greene St. StClair was not compliant with being escorted off of Duval St. to the extent Lt. Tripp used the "Bent wrist" technique to get StClair to walk. At one point, StClair's actions were so erratic Lt. Tripp and I had difficulty keeping control of StClair. Lt. Tripp and I performed a "Take down", bringing StClair to the ground and we were able to better control his body movements and escort him to Old City Hall.

When Key West Fire / Rescue arrived on scene he was transported to Lower Keys Medical Center for medical treatment. With StClair not being compliant and semi-combative I rode in the ambulance to the Emergency Room. At Lower Keys Medical Center StClair received stitches to his left hand to close the wound. StClair was given medical clearance by the Emergency Room Doctor and I transported StClair to the Monroe County Detention Center.

SUPPLEMENTAL

On 10-31-15, at about 0241, I, Lt. Tripp, saw Ofc. J. Young and Ofc. T. Clark, holding a man as if to cuff him in the 200 block of Duval. It appeared that the man was resisting being handcuffed because he had his left hand raised in the air and Ofc. Young was standing in front of him closely, as if to prepare for conflict.

As I approached, Ofc. Clark was able to get the left hand into cuffing position. I noticed that Clark was not wearing gloves and the man was bleeding heavily from his hand. I told Clark to hold on for a second as I applied gloves and switched positions with him. I then told Clark to go and wash immediately with soap and water, then find disinfectant wipes.

Ofc. Young and I walked the man to the corner of Greene and Ann. On the way, I asked Sgt. Haley to call for a rescue unit. The man kept tensing and pulling or bracing. He appeared to be severely intoxicated or under the influence of a controlled substance. He was sweating heavily, repeating himself and not making sense.

I explained that we were trying to get him medical help. At one point, he tensed and I instructed Ofc. Young to take him to the ground so that we would not loose control and get the body fluids all over us. We used a leg sweep and took him to the ground without further injury. After some coaxing, we were able to get him back on his feet and to the rescue unit.

These events were captured on my body camera.

SUPPLEMENTAL

On Saturday, 10/31/15, at approximately 0241 hours, Ofc. J. Young and I, (Ofc. T. Clark) while working an off duty detail in the 200 block of Duval St (Fantasy Fest) in full KWPD uniform. Observed two white males, Matthew StClair and Michael Sankowski physically fighting in the roadway.

StClair was actively fighting Sankowski with closed fists. Sankowski was not making attacking movements towards StClair and was attempting to stop StClair from striking him pushing him to the ground.

I grabbed a hold of Sankowski's shirt and pulled him away from StClair. Ofc. Young grabbed a hold of StClair helping separate the fight. As Ofc. Young grabbed a hold of StClair's arm, St Clair got to his feet and lunged towards me with closed fists and distracted me from Sankowski. Ofc. Young protected me from being engaged by StClair placing himself between us while I was still engaged with Sankowski giving him commands.

StClair continued to try to engage me even with Ofc. Young in his way. I saw Ofc. Young deflect StClairs attempts to attack me by pushing StClair backwards. I felt very threatened by StCalirs attempts to engage me and at this point was completely distracted from Sankowski.

When Ofc. Young pushed StClair backwards, StClair lost his balance and fell backwards unto the curb. StClair quickly got back to his feet, charging towards Ofc. Young as if to fight him. Ofc. Young withdrew his TASER, pointing it at StClair and gave him loud verbal commands to stop. StClair complied with Ofc. Young's verbal commands and stopped.

By this time, other officers arrived on scene and assisted with removing Sankowski from the scene. I approached the agitated StClair from behind and was able to place StClair into handcuffs.

Once handcuffed, I saw StClair was bleeding heavily from his left hand had a large laceration to the outside of his hand and his blood covered my left hand.

Lt. Tripp and Ofc. Young then escorted StClair to Old City Hall, the staging area so I could quickly rinse my hands of the blood.
