WHEREAS, The Key West Art Center wishes to conduct a Craft Festival Show on the day and during the hours stated above, and

WHEREAS, The Key West Art Center anticipates that over 10,000 people will be participating in the events.

NOW THEREFORE, BE IT RESOLVED, by the City Commission of the City of Key West, Florida;

SECTION 1. That the Key West Art Center is hereby granted permission to conduct a Craft Festival Show on the day and during the hours stated above; PROVIDED all trash is adequately collected and contained; guarantee indemnifying the city is executed; and provided the organizations meet the terms and conditions set forth by the City Manager.

SECTION 2. That the Key West Art Center is hereby granted permission for the closure of Whitehead Street between Greene Street and Eaton Street including Caroline Street from Telegraph Lane to Whitehead Street on the date and during the hours stated above.

SECTION 3. That the Key West Art Center will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.
