An administrative hearing before the Tree Commission for the City of Key West will be held on **Tuesday, December 8, 2015,** at 5:00 p.m., at Old City Hall, 510 Green St. Key West, Florida.

This hearing will be conducted pursuant to sections 110-288 et. seq. of the Key West City Code. The purpose of this hearing will be to determine if a code violation has been committed by the above named Respondent. Your presence is required at this Tree Commission meeting.


Date of alleged violation: prior to August 24, 2015 at 119-159 Simonton Street, Key West, Florida

Alleged code violation: Sec. 110-256. Tree abuse.

- (a) Generally. Tree abuse is prohibited, and abused trees shall not be counted toward fulfilling landscape requirements. The city may require the abused trees to be replaced.
- (b) Prohibited acts. A tree shall be considered abused if a person takes an action so that one of the following occurs:
 - (1) Significant damage has been inflicted upon any part of a tree, including the root system, by machinery, storage of materials, soil compaction, excavation, vehicle accidents, chemical application or change to the natural grade.
 - (2) Damage inflicted to or cutting upon a tree which permits infection or pest infestation.
 - (3) Cutting upon any tree which permanently reduces the function of the tree or causes it to go into irreversible decline.
 - (7) Tears and splitting of limb ends or peeling and stripping of bark. Key to the Caribbean – average yearly temperature 77 ° Fahrenheit.

Factual allegation: On March 9, 2015, a permit was issued to transplant/relocate 1-Pigeon Plum and 1-Thatch Palm (T15-7307) according to ANSI A-300 Standards. Shade Tree Service had been hired to transplant the trees and root pruning of the trees was being done. On or about August 24, 2015, the tree was pulled out of the ground by Toppino & Sons with no guidance from Shade Tree Services. Their method caused a significant amount of bark to be removed from the tree and caused damage to the tree, in violation of ANSI A-300 transplanting standards.

If the Tree Commission for the City of Key West finds that there has been a violation of the above code section, it will elect to enter into a compliance settlement agreement pursuant to section 110-291 of the Key West City Code or recommend a fine and further hearing before the Special Master of The City of Key West pursuant to section 110-294 of the Key West City Code.

Attendees are hereby notified that a complete and accurate record of the proceeding is required under Florida Statute 286.0105 if an appeal is sought. Appellants are responsible for providing transcription services.



STAFF REPORT

DATE: November 23, 2015

RE: Administrative Hearing, 119-159 Simonton Street



A complaint was received on or about August 24, 2015 regarding the transplanting of a pigeon plum tree at the development project located at 119-159 Simonton Street. A permit had been issued to transplant that tree in March 2015 (T15-7307). The permit was issued to Key West 07 LLC and Carl Gilley (representative). I was made aware that John Cole with Shade Tree Services was actually doing the transplantation work. Contact was made with John Cole reading the complaint. He stated that he had been root pruning the tree in

preparation for transplanting and his workers had not relocated the tree. He said a worker from Toppino's in a dozer, wrapped straps around the base of the tree and pulled it out of the ground.

An inspection of the pigeon plum indicated that the tree had been replanted. The tree showed obvious signs of damage primarily to the trunks of the tree and to the canopy. Several location near the base of the tree had bark stripped from the trunk.






