TO 11:00 P.M. ON SATURDAY, FEBRUARY 13, 2016 AND SUNDAY, FEBRUARY 14, 2016; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES ON THE DATE AND **DURING THE HOURS STATED ABOVE; PROVIDING FOR AN EFFECTIVE** DATE

NOW THEREFORE, BE IT RESOLVED by the City Commission of the City

of Key West, Florida:

**SECTION 1.** That the Marques Butler Memorial Scholarship, Inc. is hereby

granted permission to conduct a Fundraiser on the day and during the hours stated above;

PROVIDED that all trash is adequately collected and contained; that a guarantee

indemnifying the city is executed; and the organization meet the terms and conditions set

forth by the City of Key West and that 100% of the money collected shall be donated to

the Marques Butler Memorial Scholarship Fund to benefit numerous Key West High

School Seniors.

**SECTION 2.** That pursuant to Section 18-86 of the Key West Code of

Ordinances, the Marques Butler Memorial Scholarship, Inc. is hereby granted permission to allow the sale and consumption of alcoholic beverages.

**SECTION 3.** The Marques Butler Memorial Scholarship, Inc. is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

**SECTION 4.** The Marques Butler Memorial Scholarship, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrel will be used and that they will be placed side by side.

**SECTION 5.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
