A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RATIFYING AN EMERGENCY CHANGE ORDER APPROVAL APPROVED BY THE CITY MANAGER ON DECEMBER 23, 2015, AS PROVIDED FOR UNDER SECTION 2-797(2) AND 2-845 OF THE CODE OF ORDINANCES, AUTHORIZING A CHANGE ORDER IN THE AMOUNT OF \$9,285.54 FOR ADDITIONAL WORK REQUIRED TO COMPLETE THE INTERIOR/EXTERIOR PAINTING OF KW FIRE AND POLICE DEPARTMENT (ITB 15-023); PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 15-248, the City Commission awarded a bid to P2M General Contracting Services, Inc. for interior and exterior painting in response to ITB 15-023; and

WHEREAS, ITB 15-023 specified two coats of paint on interior areas, however, in some areas at the KWPD, two coats were not adequate to completely cover the previous color; and

WHEREAS, in order to cover the affected areas, the contractor requested a change order to apply a third coat of paint, and City staff has determined that the request is costeffective and will not require a time extension on the project; and

WHEREAS, the City Manager acted without delay, using emergency powers authorized under Section 2-797(2) and 2-845 of

the City's Code of Ordinances, to authorize and procure the necessary change order to ensure prompt completion of the painting project; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached emergency change order dated December 23, 2015 by the City Manager, pursuant to section 2=797(2) and 2-845 of the Code of Ordinances, for additional work to complete the project set forth in ITB 15-023, is hereby approved, in the amount of \$9,285.54 to P2M General Contracting Services, Inc.

Section 2: That adequate funding for this change order is budgeted under FY 15-16 account 001-1909-519-46.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
