A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA APPROVING A MONTH-TO-MONTH EXTENSION OF THE CONTRACT BETWEEN THE CITY AND ARAMARK UNIFORM SERVICES, A DIVISION OF ARAMARK UNIFORM AND CAREER APPAREL, LLC, FOR THE PROVISION OF CITY STAFF UNIFORM RENTALS FOR A PERIOD NOT TO EXCEED APRIL 30, 2016; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 11-031, the City Commission awarded a three year contract to Aramark in response to ITB 11-005 for uniform services, and in Resolution No. 14-008 the City Commission approved a two-year extension of the contract; and

WHEREAS, City Staff issued ITB #009-16 for Uniform Rental Services and received no bids in response by the closing date of December 10, 2015; and

WHEREAS, pursuant to Teamsters, PBA and IAFF collective bargaining agreements, the City is required to provide work uniforms for employees who require special clothing due to the nature of their job; and

WHEREAS, City staff contacted Aramark and determined that the company is willing to continue to provide uniforms, on a month-to-month basis, pursuant to the terms contained in the contract, to allow staff time to obtain price quotes; and

WHEREAS, City staff recommends a month-to-month extension of the Aramark contract, through April 2016, or until such time as a new contract is awarded or the end of FY 2016, whichever comes first.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That a month-to-month extension of the contract awarded in Resolution No. 11-031 and extended in Resolution No. 14-008 between the City and Aramark Uniform Services for uniform rentals in accordance with ITB #11-005, is hereby approved through April 2016, or until such time as a new contract is awarded, whichever comes first.

Section 2: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
