Barnett, Neely said he then stood up for his friend and told Jourdan to stop. Neely said he got into a verbal argument with Jourdan and thats when Jourdan began to verbally threaten him. Neely said Jourdan then walked back and forth from Walgreens to Apprlerouth Lane. Jourdan at some point retrieved a black knife, with approximately a four inch black blade. Neely said he observed Jourdan throwing the knife into the parking lot, prior jumping the fence.

Neely completed a sworn witness statement, I placed his statement into KWPD Records Division. Ofc. A. Rodriguez, Ofc. C. Rhinhart, Det. Siracuse, Det. M. Diaz and Ofc. C. Williams all arrived on scene.

Ofc. C. Williams, Ofc. Rhinhart and both detectives went to search the parking lot on the North side of Apprlerouth Lane for the knife that Jourdan threw.

I met with Lauryn B Barnett (Witness), Barnett stated the following:

Jourdan was confrontational with Barnett inside and outside of Walgreens, because she told Jourdan he was being disrespectful towards the employees. Barnett said Jourdan went in and out of Walgreens on numerous occasions and "verbally assaulted" her. Barnett said Neely then told Jourdan to leave her alone. Barnett said she observed the confrontation as it escalated and Jourdan threatening Neely with a knife.

Barnett wrote a sworn witness statement, I placed her statement into KWPD Records Division. I attempted to talk with Jourdan, as I read Jourdan the Miranda Warning, he kept saying he could not understand me. Jourdan said my accent was to thick and he couldn't understand what I was saying. Det. Diaz then read him the Miranda Warning so Jourdan could understand it better. Jourdan said he still did not understand his rights. Jourdan said he was mentally retarded with an IQ of 8 and dyslexic. Jourdan did spontaneously uttered that Neely was way bigger than him and he would have used the knife if he had it.

As I was talking to Jourdan, Ofc. Rhinhart was able to locate the knife that fit the description of the witnesses accounts. I took pictures of the knife and where it was located. I uploaded the photos into KWPD COBAN SYSTEM. I placed the knife into KWPD property/evidence section.

While running Jourdan on KWPD communication channel 2 for warrants. KWPD dispatch advised me that Jourdan has a warrant for unlawful disposal of trash.

I informed Jourdan that he was under arrest for aggravated assault with a deadly weapon and for the outstanding warrant.

I then transported Jourdan to MCDC without further incident.

This incident was recorded on my BWC.
