Upon my arrival, Ofc. M. Hansell was already on scene and was speaking with the two suspects on property. One of the suspects was identified as Scott Alan King, DOB 04/20/1952. Mr. King became an issue early into Ofc. M. Hansell's investigation because he kept yelling homophobic

epithets so the same sex couple who lives next door and reported the trespassing could hear him. Ofc. M. Hansell asked Mr. King several times to stop using the slurs. However, over the course of fifty minutes Mr. King called the neighbors "Faggots", "Fags" "Fuck Boys" and "Assholes more than a dozen times.

In order to better maintain control the situation I instructed Mr. King to walk to the front of the property away from the neighbors. As Mr. King was walking down the driveway to the front of the property he began to yell at the neighbors, saying "Fuck you, you fucking faggots." "Suck my dick." "Pussy ass faggot mother fuckers."

Mr. King continued to yell homophobic slurs and vulgarities in a residential neighborhood from 11:11pm to 11:40pm despite being asked to lower his voice multiple times. Mr. King's conduct gave me reason to believe that he was not only breaching the peace, but that his conduct may be considered offensive to the general public. I spoke with the neighbor who I identified as Mark A. Patterson, DOB 04/12/1965. Mr. Patterson told me that he found Mr. King's conduct disruptive and offensive.

As a result of Mr. King breaching the peace and being disorderly in public, I arrested Mr. King for violation of Florida Statue 877.03- Breach of the peace; disorderly conduct.

To Wit:

877.03-BREACH OF THE PEACE; DISORDERLY CONDUCT.-Whoever (SCOTT ALAN KING) commits such acts as are of a nature to corrupt the public morals, or outrage the sense of public decency (AS MR. KING WAS WALKING DOWN THE DRIVEWAY TO THE FRONT OF THE PROPERTY HE BEGAN TO YELL AT THE NEIGHBORS, SAYING "FUCK YOU, YOU FUCKING FAGGOTS." "SUCK MY DICK." "PUSSY ASS FAGGOT MOTHER FUCKERS."), or affect the peace and quiet of persons who may witness them (MR. KING CONTINUED TO YELL HOMOPHOBIC SLURS AND VULGARITIES IN A RESIDENTIAL NEIGHBORHOOD FROM 11:11PM TO 11:40PM DESPITE BEING ASKED TO LOWER HIS VOICE MULTIPLE TIMES/ I SPOKE WITH THE NEIGHBOR WHO I IDENTIFIED AS MARK A. PATTERSON, DOB 04/12/1965. MR. PATTERSON TOLD ME THAT HE FOUND MR. KING'S CONDUCT DISRUPTIVE AND OFFENSIVE.), or engages in brawling or fighting, or engages in such conduct as to constitute a breach of the peace or disorderly conduct, shall be guilty of a misdemeanor of the second degree, punishable as provided in s. 775.082 or s. 775.083.

While transporting Mr. King to the jail he became increasingly agitated. Mr. King began yelling "Fuck you Nigger." "I hate black people." "You ain't nothing but a fuck boy." "I hope you get shot in the face." At one point Mr. King began to chant "Nigger" repeatedly. The entire transport to the Monroe County Detention Center was captured on the COBAN recording system in my patrol car.

Once we arrived at the Detention Center I activated my Key West Police Issued Body Camera. As I began to walk Mr. King to the doors that lead to the elevator Mr. King refused to continue walking forward and kept turning towards me. Mr. King also kept tensing and pulling his arm away from me in an attempt to break my hold on him. I instructed Mr. King to stop pulling and to continue walking to the door. Mr. King refused to comply with my instruction and continued to tense and pull and attempt to turn towards me. In order to maintain control of Mr. King I redirected him to the floor. Once I was able to gain control of Mr. King on the floor I requested assistance and a supervisor.

Once assistance came I began to walk Mr. King to the elevator door, once in the elevator Mr. King continued to resist by tensing, trying to turn and break my hold on him. I forced Mr. King against the elevator door in an effort to maintain my hold on him. Once I was able to secure my hold on Mr. King he kicked me with his right leg.

When Mr. King kicked me he did so in an attempt to resist and defeat my lawful effort to maintain control of him and in doing so Mr. King violated Florida Statue 843.01-Resisting An Officer With Violence.

	On 12-20-2015, I Matthew Hansell along with Ofc. Andruzzi and Ofc. Bouvier, were dispatched to 714 Elizabeth St. in reference to possible trespassers.	
	Upon arrival I made contact with two subjects sleeping on the back porch. I woke both subjects up and obtained their identifications. As I spoke with both subjects King, who was noticeably intoxicated, began ranting and complaining about being harassed and that he had the right to be on the property.	
	King would not stop talking about having permission to be on the property and questioned me every time I tried to reason with him. King smelled of a strong odor of an alcoholic beverage coming from his person and had bloodshot watery eyes.	
	At one point King looked over at the same sex couple next door calling them, " fags. " I had channel 2 run both King's and Hiller's information in between King's tirade.	
	I had Ofc. Bouvier stay with both subjects and I eventually met with the property owner Tony Gregory. prior to speaking with Tony myself and Ofc. Andruzzi spoke with the neighbors / complainants.	
	I explained to Tony what was occurring and Tony said that King works on the property. Tony said that King will stay on the property from time to time, however he tends to get into arguments with the neighbors.	
	As I was talking with Tony, King came walking down the drive way. I could here King cursing as he made his way toward the front side walk.	
	Ofc. Bouvier was behind King and placed him into custody at his cruiser. A very belligerent King was then searched and placed in the rear of Ofc. Bouvier's cruiser.	
	Ofc. Bouvier explained that King began cursing at the neighbors, calling them derogatory names.

On Sunday December 20, 2015 at approximately 11:05pm, I, Ofc. K. Bouvier responded to 714 Elizabeth Street in reference to a call of trespassers on the property.

Upon my arrival, Ofc. M. Hansell was already on scene and was speaking with the two suspects on property. One of the suspects was identified as Scott Alan King, DOB 04/20/1952. Mr. King became an issue early into Ofc. M. Hansell's investigation because he kept yelling homophobic epithets so the same sex couple who lives next door and reported the trespassing could hear him. Ofc. M. Hansell asked Mr. King several times to stop using the slurs. However, over the course of fifty minutes Mr. King called the neighbors "Faggots", "Fags" "Fuck Boys" and "Assholes more than a dozen times.

In order to better maintain control the situation I instructed Mr. King to walk to the front of the property away from the neighbors. As Mr. King was walking down the driveway to the front of the property he began to yell at the neighbors, saying "Fuck you, you fucking faggots." "Suck my dick." "Pussy ass faggot mother fuckers."

Mr. King continued to yell homophobic slurs and vulgarities in a residential neighborhood from 11:11pm to 11:40pm despite being asked to lower his voice multiple times. Mr. King's conduct gave me reason to believe that he was not only breaching the peace, but that his conduct may be considered offensive to the general public. I spoke with the neighbor who I identified as Mark A. Patterson, DOB 04/12/1965. Mr. Patterson told me that he found Mr. King's conduct disruptive and offensive.

As a result of Mr. King breaching the peace and being disorderly in public, I arrested Mr. King for violation of Florida Statue 877.03- Breach of the peace; disorderly conduct.

To Wit:

877.03-BREACH OF THE PEACE; DISORDERLY CONDUCT.-Whoever (SCOTT ALAN KING) commits such acts as are of a nature to corrupt the public morals, or outrage the sense of public decency (AS MR. KING WAS WALKING DOWN THE DRIVEWAY TO THE FRONT OF THE PROPERTY HE BEGAN TO YELL AT THE NEIGHBORS, SAYING "FUCK YOU, YOU FUCKING FAGGOTS." "SUCK MY DICK." "PUSSY ASS FAGGOT MOTHER FUCKERS."), or affect the peace and quiet of persons who may witness them (MR. KING CONTINUED TO YELL HOMOPHOBIC SLURS AND VULGARITIES IN A RESIDENTIAL NEIGHBORHOOD FROM 11:11PM TO 11:40PM DESPITE BEING ASKED TO LOWER HIS VOICE MULTIPLE TIMES/ I SPOKE WITH THE NEIGHBOR WHO I IDENTIFIED AS MARK A. PATTERSON, DOB 04/12/1965. MR. PATTERSON TOLD ME THAT HE FOUND MR. KING'S CONDUCT DISRUPTIVE AND OFFENSIVE.), or engages in brawling or fighting, or engages in such conduct as to constitute a breach of the peace or disorderly conduct, shall be guilty of a misdemeanor of the second degree, punishable as provided in s. 775.082 or s. 775.083.

While transporting Mr. King to the jail he became increasingly agitated. Mr. King began yelling "Fuck you Nigger." "I hate black people." "You ain't nothing but a fuck boy." "I hope you get shot in the face." At one point Mr. King began to chant "Nigger" repeatedly. The entire transport to the Monroe County Detention Center was captured on the COBAN recording system in my patrol car.

Once we arrived at the Detention Center I activated my Key West Police Issued Body Camera. As I began to walk Mr. King to the doors that lead to the elevator Mr. King refused to continue walking forward and kept turning towards me. Mr. King also kept tensing and pulling his arm away from me in an attempt to break my hold on him. I instructed Mr. King to stop pulling and to continue walking to the door. Mr. King refused to comply with my instruction and continued to tense and pull and attempt to turn towards me. In order to maintain control of Mr. King I redirected him to the floor. Once I was able to gain control of Mr. King on the floor I requested assistance and a supervisor.

Once assistance came I began to walk Mr. King to the elevator door, once in the elevator Mr. King continued to resist by tensing, trying to turn and break my hold on him. I forced Mr. King against the elevator door in an effort to maintain my hold on him. Once I was able to secure my hold on Mr. King he kicked me with his right leg.

When Mr. King kicked me he did so in an attempt to resist and defeat my lawful effort to maintain control of him and in doing so Mr. King violated Florida Statute 843.01-Resisting An Officer With Violence.

To Wit:

843.01-RESISTING OFFICER WITH VIOLENCE TO HIS OR HER PERSON.-Whoever knowingly (SCOTT ALAN KING) and willfully resists, obstructs, or opposes any officer (ONCE IN THE ELEVATOR MR. KING CONTINUED TO RESIST BY TENSING, TRYING TO TURN AND BREAK MY HOLD ON HIM. I FORCED MR. KING AGAINST THE ELEVATOR DOOR IN AN EFFORT TO MAINTAIN MY HOLD ON HIM. ONCE I WAS ABLE TO SECURE MY HOLD ON MR. KING HE KICKED ME WITH HIS RIGHT LEG). as defined in s. 943.10(1), (2), (3), (6), (7), (8), or (9); member of the Florida Commission on Offender Review or any administrative aide or supervisor employed by the commission; parole and probation supervisor; county probation officer; personnel or representative of the Department of Law Enforcement; or other person legally authorized to execute process in the execution of legal process or in the lawful execution of any legal duty(I, K. BOUVIER WAS AT THE TIME OF THIS INCIDENT EMPLOYED AS A POLICE OFFICER BY THE CITY OF KEY WEST. I WAS WEARING MY CLASS B UNIFORM WHILE LAWFULLY AFFECTING MR. KINGS ARREST.), by offering or doing violence (ONCE I WAS ABLE TO SECURE MY HOLD ON MR. KING HE KICKED ME WITH HIS RIGHT LEG.) to the person of such officer or legally authorized person, is guilty of a felony of the third degree, punishable as provided in s. 775.082, s. 775.083, or s. 775.084.

Once Mr. King was turned over to detention staff he continued his barrage racial and homophobic slurs.

Mr. King was treated by medical staff at the jail for minor abrasions to his right cheek and forehead area which he suffered as a result of being redirected to the floor.
