On December 31, 2015, I responded to Panini Panini located at 1075 Duval Street C10, in reference to a white male wearing a white shirt and black pants who had thrown plates at the door.

Ofc. Malgrat and Ofc. T. Mitchell arrived on the Duval Street side and I went to the Simonton Street side of Duval Square. I made contact with the caller Mr. Stevens Arteaga. Mr. Arteaga stated that the suspect, later identified as Tony Bethel had thrown all the chairs out side of the business all over the place and he had kicked the door. Additionally Mr. Arteaga stated the Bethel had stolen a leaf blower from the maintenance workers.

As I was speaking with Mr. Arteaga Bethel returned to the property from the area of the Gato Building located at 1100 Simonton Street. Mr. Arteaga pointed at Bethel and said, "That's him"! I got out of My marked patrol car and ordered Bethel to Stop. Bethel looked at me and took off running between the stores located in Duval Square. I chased Bethel into the center of Duval Square. The maintenance workers were pressure washing the ground and there was standing water on the ground. I removed my Taser from its holster as I was chasing Bethel. I turned My Taser on and pulled the trigger just as Bethel slipped on the wet floor. Only one probe from my Taser struck Bethel on his right side and the Taser was not effective. I continued to chase Bethel to the Duval Street entrance of Duval Square. Ofc. Malgrat was standing on the Duval Street side of Duval Square. I yelled to Ofc. Malgrat, "That's him Tase him Tase him." Ofc.Malgrat displayed his Taser and ordered Bethel to the ground. Bethel complied and I handcuffed him. Ofc. Malgrat removed the Taser probe that struck Bethel on his right hip area. Bethel did not have any apparent injuries or complain of injuries from this incident. The only visible injury Bethel had was from the Taser probe. Ofc. Malgrat secured Bethel in the rear of his marked patrol car. Ofc. Malgrat stated that he had removed Bethel from the property prior to this incident and warned him he would be arrested for trespassing if he returned.

Next I met with Mr. Jose Hernandez from the maintenance crew. Mr. Hernandez stated that Bethel did steal his blower from their work area. Mr. Hernandez had since recovered his blower from parking lot area behind the Gato building. I asked Mr. Hernandez how much his blower cost? Mr. Hernandez said it cost somewhere around \$200.00. I called Strunk Hardware the only Authorized dealer for Sthil equipment in Key West and asked for a replacement cost of the Sthil model BG86 blower. I was given a replacement cost of \$249.99.

Next I spoke with Mr. Arteaga and Ms. Dawn Vincent, the owner of Panini Panini. Mr. Arteaga stated that Bethel had first thrown all of their outdoor chairs all over the place then he kicked the door. Mr. Arteaga stated that Bethel had caused about \$100.00 worth of damage to the door and he had told him to leave their property multiple times and Bethel refused to leave. Next I spoke with Ms. Vincent. Ms. Vincent stated that this incident was not the first incident her business has had with Bethel and she wanted him trespass warned from the property in addition to the criminal charges for damaging the property.

Next I returned to my marked patrol car and drove to the Duval Street side of Duval Square. Ofc. Malgrat removed Bethel from his marked patrol car and placed him into the rear of my marked patrol car. I transported him to MCDC for processing. While en route to MCDC Bethel asked what his charges were and I told him he was being charged with theft, criminal mischief, trespassing, and

resisting. Bethel stated several times that his family would take care of it and he would be out tomorrow. We arrived at MCDC without incident. While in the elevator Bethel asked if I knew who his family was? Then he said "the police are not shit, the courts and Judges are not shit my family will take care of this." The Judge will let me out tomorrow because they know who my family is.

I photographed Bethel's right hip area to document the his injury from the Taser probe.

Bethel did knowingly and intentionally steal a Sthil model BG86 blower from Mr. Hernandez, depriving him of the use of his property which is in violation of F.S. 812.014(1)

Bethel did knowingly and intentionally kick the door to Panini Panini causing about \$100.00. in damage to the business which is in violation of F.S. 806.13(1)(B)(1).

Bethel did knowingly and intentionally enter and remain on a property after he was given notice that he was not allowed on the property which is in violation of F.S. 810.09(2)(B).

Bethel did knowingly and intentionally resist my lawful commands while I was executing my lawful duties which is in violation of F.S. 843.02.

all over the place and he had kicked the door. Additionally Mr. Arteaga stated the Bethel had stolen a leaf blower from the maintenance workers,

As I was speaking with Mr. Arteaga Bethel returned to the property from the area of the Gato Building located at 1100 Simonton Street. Mr. Arteaga pointed at Bethel and said, "That's him"! I got out of My marked patrol car and ordered Bethel to Stop. Bethel looked at me and took off running between the stores located in Duval Square. I chased Bethel into the center of Duval Square. The maintenance workers were pressure washing the ground and there was standing water on the ground. I removed my Taser from its holster as I was chasing Bethel. I turned My Taser on and pulled the trigger just as Bethel slipped on the wet floor. Only one probe from my Taser struck Bethel on his right side and the Taser was not effective. I continued to chase Bethel to the Duval Street entrance of Duval Square. Ofc. Malgrat was standing on the Duval Street side of Duval Square. I yelled to Ofc. Malgrat, "That's him Tase him." Ofc.Malgrat displayed his Taser and ordered Bethel to the ground. Bethel complied and I handcuffed him. Ofc. Malgrat secured Bethel in the rear of his marked patrol car. Ofc. Malgrat stated that he had removed Bethel from the property prior to this incident and warned him he would be arrested for trespassing if he returned.

Next I met with Mr. Jose Hernandez from the maintenance crew. Mr. Hernandez stated that Bethel did steal his blower from their work area. Mr. Hernandez had since recovered his blower from parking lot area behind the Gato building. I asked Mr. Hernandez how much his blower cost? Mr. Hernandez said it cost somewhere around \$200.00. I called Strunk Hardware the only Authorized dealer for Sthil equipment in Key West and asked for a replacement cost of the Sthil model BG86 blower. I was given a replacement cost of \$249.99.

Next I spoke with Mr. Arteaga and Ms. Dawn Vincent, the owner of Panini Panini. Mr. Arteaga stated that Bethel had first thrown all of their outdoor chairs all over the place then he kicked the door. Mr. Arteaga stated that Bethel had caused about \$100.00 worth of damage to the door and he had told him to leave their property multiple times and Bethel refused to leave. Next I spoke with Ms. Vincent. Ms. Vincent stated that this incident was not the first incident her business has had with Bethel and she wanted him trespass warned from the property in addition to the criminal charges for damaging the property.

Next I returned to my marked patrol car and drove to the Duval Street side of Duval Square. Ofc. Malgrat removed Bethel from his marked patrol car and placed him into the rear of my marked patrol car. I transported him to MCDC for processing. While en route to MCDC Bethel asked what his charges were and I told him he was being charged with theft, criminal mischief, trespassing, and resisting. Bethel stated several times that his family would take care of it and he would be out tomorrow. We arrived at MCDC without incident. While in the elevator Bethel asked if I knew who his family was? Then he said "the police are not shit, the courts and Judges are not shit my family will take care of this." The Judge will let me out tomorrow because they know who my family is.

Bethel did knowingly and intentionally steal a Sthil model BG86 blower from Mr. Hernandez, depriving him of the use of his property which is in violation of F.S. 812.014(1)

Bethel did knowingly and intentionally kick the door to Panini Panini causing about \$100.00. in damage to the business which is in violation of F.S. 806.13(1)(B)(1).

Bethel did knowingly and intentionally enter and remain on a property after he was given notice that he was not allowed on the property which is in violation of F.S. 810.09(2)(B).

Bethel did knowingly and intentionally resist my lawful commands while I was executing my lawful duties which is in violation of F.S. 843.02.
