## RESOLUTION NO.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE PURCHASE AND INSTALLATION OF A MOBILE DATA TERMINAL UPGRADE FROM SYNCROMATICS REAL TIME CORPORATION FOR THE **PASSENGER** INFORMATION SYSTEM (RTPI) MANAGEMENT/HOSTING AS SET FORTH IN THE ATTACHED "SYNCROMATICS CORPORATION AND CITY OF KEY WEST DEPARTMENT OF TRANPSORTATION HARDWARE ADDENDUM" FOR USE IN KEY WEST DEPARTMENT OF TRANSPORTATION BUSES ON A SOLE SOURCE BASIS, AND IN THE BEST INTERESTS OF THE CITY, PURSUANT TO SECTION 2-797(1) AND 2-797(4)(b)OF THE ORDINANCES; CODE OF PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 08-087, the City Commission awarded a bid for a Real Time Passenger Information system (RTPI) to Syncromatics, Inc., and in Resolution No. 14-009 a second five-year agreement was approved on a sole-source basis; and

WHEREAS, technical upgrades are necessary, due to the evolution of cellular service (2G service is no longer available as a community standard), and in order to ensure continued operability of the Syncromatics RTPI system, City staff recommends the purchase of a Syncromatics Mobile Data Terminal Upgrade; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase and installation of a Syncromatics Mobile Data Terminal Hardware Upgrade, as set forth in the attached "Syncromatics Corporation and City of Key West, Department of Transportation Hardware Addendum" is hereby approved in an amount not to exceed \$28,615.00, pursuant to section 2-797(1) and 2-797(4)(b) of the Code of Ordinances.

Section 2: That the City Manager is authorized to execute the "Syncromatics Corporation and City Key West, Department of Transportation Hardware Addendum" on behalf of the City of Key West.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
