On January 1, 2016, at approximately 0313 hours, I (Sgt. Matthew Haley) was working a city detail for the New Year's Eve celebration on the 200 block of Duval Street. I was standing on the corner of Caroline and Duval Street with K-9 Officer Richardson, when a black male who was identified to me by K-9 Officer Richardson as Duane Clarke walked past us. K-9 Officer C. Richardson was aware that Clarke had an active warrant for violation of probation out of Monroe County, Florida. K-9 Officer Richardson and I made contact with Duane Clarke by Fogarty's Restaurant at 227 Duval Street. When we made contact with Duane Clark, I notice him quickly place his right hand in his right front short's pocket. I asked Duane Clarke to remove his hand from his short's pocket. When Clarke complied, removing his hand from his pocket, K-9 Officer Richardson noticed a clear bag with an unknown off white substance in Duane Clark's right hand. K-9 Officer Richardson grabbed Duane Clarke's right wrist telling him to let go of the clear bag. When K-9 Officer Richardson grabbed Duane Clarke's right wrist, I grabbed Duane Clarke's left wrist as Duane Clarke began struggling with us, attempting to break free from are grasp. Duane Clarke was given loud verbal commands to stop resisting, however, he failed to comply. Duane Clarke was actively resisting, using evasive movements (pulling away, tensing his body) to defeat our efforts to control him. To gain better control of Duane Clarke, K-9 Officer Richardson and I escorted Clarke to the ground. While on the ground, Clarke was able to put

the bag which contained the unknown substance in his mouth and placed his hands underneath his person. Clarke continued to ignore verbal commands to comply and place his hands behind his back. I deployed my department issue Taser, removed the air cartridge and told Clarke if he did not comply he would be tased. Clarke continued to ignore our commands. I used my Taser device and completed a 1 cycle drive-stun to the left back shoulder area of Clarke's person. After the cycle was completed, Clarke complied and placed his hands behind his back and was handcuffed.

Once Clarke was handcuffed, additional Officers (Sgt. F. Duponty, Officer M. Hansell, and Officer A. Rodriguez) arrived to assist. Officer M. Hansell and Officer A. Rodriguez utilized pressure points on Clarke's jaw area preventing him from swallowing the substance in his mouth. After several minutes, Clarke eventually complied with our commands and spit out the bag. The clear bag which came out of Clarke's mouth had several individual wrapped small bags inside the large bag with substances which FTP for Cocaine (7 small bags Cocaine, 7.2g) and Heroin (1 small bag Heroin, .9g).

My BWC was active only for portions of the above events, because I was unable to activate the BWC during the struggle with Clarke.

My department issued Taser video was downloaded onto a CD by Sgt. D. Barrios. I placed the CD into evidence. Sgt. F. Duponty took photographs of Clarke's person. I downloaded the photographs into DPM.

On 01-01-2015, I Matthew Hansell of the Key West Police Department was working an off duty detail at Caroline St. and Duval St.

I was walking back from the Old City Hall when dispatched advised that K-66 requested assistance at Caroline St. and Duval St. As I approached the corner of the Caroline St. and Duval St. I could see K-9 Ofc. Richardson, Sgt. Haley and Ofc. Rodriguez on the ground trying to detain Clarke.

I assisted with hand cuffing Clarke and eventually stood him up. It was quickly determined that Clarke had put narcotics in his mouth and was trying to swallow it.

I applied a pressure point to the right and left side of Clarke's lower jaw in an attempt to get him to spit the narcotics out. Clarke pulled and tried to walk away from me several times as I tried to gain control of him. Eventually Clarke spat the narcotics out and it was recovered by Ofc. Rodriguez.

I eventually walked Clarke to Old City Hall and he was turned over to officers. I had no further evolvement with this case.

This incident was recorded on BODY CAM.

On January 1, 2016 at approximately 0318 hours, I (Ofc. A. Rodriguez) arrived at the scene of an active drug investigation. Minutes prior, I heard K-9 Ofc. C. Richardson ask for additional officers at Caroline Street and Duval Street over Key West Dispatch Channel One.

When I arrived, I saw Ofc. M. Hansell and Det. K. Malsheimer with control of each of Duane Everton Clarke's arms. I also saw a bulge in Clarke's left cheek and I overheard an officer state that Clarke was attempting to swallow something, possibly a bag of cocaine.

I gained control of the back of Clarke's neck with my right hand and tilted his head and body forward in an attempt to prevent Clarke from swallowing the substance. I also used my left hand to restrict the ability of Clarke to swallow by applying pressure to the underneath of the rear of his jawbones. During this time, I monitored Clarke's ability to speak and breathe without issue and could hear Clarke speaking clearly to me. I told Clarke numerous times to spit the bag out of his mouth and that it was not worth his life. Clarke told me he wished to speak to a female that was present on scene and I explained to him that I would like for him to speak to her as well, but that he would need to spit the bag out of his mouth. Clarke told me multiple times that he did not want to die and I told him he needed to spit the bag out.

I then saw Clarke maneuver the object in his mouth from his left cheek to the front of his mouth and then produce the bag from his mouth. I used my left hand and took possession of the bag that appeared to contain numerous bags of a white powdery substance. I also saw a brown powdery substance within the larger bag as well.

I transported the bag of suspected cocaine and heroin to the KWPD for processing. I field tested the suspected cocaine and heroin and both field tested positive for cocaine and heroin. I assisted K-9 Ofc. C. Richardson in processing the property.

My BWC captured the incident.

I had no further involvement in this case.

On 01/01/16, at 0313 hours, I (K-9 Ofc. C. Richardson) was on foot patrol at the intersection of Caroline Street and Duval Street when I observed an individual I know as, Duane Clarke (AKA Shorty), walked past me. I knew Clarke had an active warrant out of MCSO for violation of probation.

I walked in front of Clarke to prevent him from running into the large crowd gathered for the New Year's celebration, as Sgt. Haley approached Clarke from the other side. When I heard Sgt. Haley ask Clarke to take his hands out of his pants pocket, I noticed a clear bag with an unknown off white substance in his right hand, from my training an experience, I believed the substance in the clear bag to be narcotics, due to the shape and packaging. Clarke attempted to bring his right hand towards his mouth. I grabbed his right wrist and began giving him loud verbal commands to drop the substance and stop resisting. Clarke started to pull away from Sqt. Haley and myself ignoring my verbal commands. To gain better control of Clarke, Sgt. Haley and I escorted Clarke to the ground. While on the ground, Clarke was able to place the unknown substance in his mouth. Clarke continued to ignore our loud verbal commands, placing his hands underneath his body and continuing to tense his arms preventing us to handcuff him. Sgt. Haley utilized his taser and dried stunned Clarke in the left shoulder area.

Once Clark was secured in handcuffs, I continued to give Clarke loud verbal commands to spit out the clear bag which contained an unknown off white substance. Officer Rodriguez came over to assist and was able make Clarke spit out the clear bag which contained an unknown off white substance.

Clarke was then escorted to the rear of 510 Green Street for processing before being placed into the rear of the KWPD transport van. Clarke was then transported by Ofc. D. Blanco to the KWPD.

Ofc. A. Rodriguez processed and packaged the narcotics.

Once the main bag containing multiple other bags was opened, it revealed 7 total bags of FTP cocaine (7.2g) and 1 total bag of FTP Heroin (0.9g).

While completing the affidavit, Clarke escaped custody from the KWPD. A search of the immediate area was conducted, with negative results.

Clarke did escape from custody, by stealthily exiting the KWPD while under arrest for multiple charges, in violation of FSS, 944.04

Due to the packaging in small amounts of the cocaine, Clarke was in possession of cocaine with intent to sell in violation of FSS, 893.13(1A1).

Clarke was in possession of a controlled substance without a prescription (FTP Heroin), in violation of FSS, 893.13(6A)

Clarke did tamper with evidence by placing and attempting to swallow the bag containing the narcotics, in violation of FSS, 918.13

Clarke did resist without violence by not obeying our verbal commands, tensing his extremities, and pulling away, in violation of FSS, 843.02
