Incident Report

Topic **ORIGINAL**

On 1/9/2016 at approximately 1355 hours, KWPD Officers responded to 629 Caroline Street in reference to trespassers. A resident of the property, Madeleine Alvarez, called KWPD to advise that there were several homeless subjects on the property drinking and causing a disturbance. Alvarez advised they were behind a wooden fence that was posted with several no trespassing signs.

Upon arrival, I (Ofc M Malgrat) observed three white males known to me as Robert Barnes, Scott Traver, and Jackie Bowling. Barnes, Traver, and Bowling were sitting on a concrete stoop behind a wooden picket fence that was clearly posted with several no trespassing signs. The stoop was attached to the building as part of the curtilage. All three individuals were clearly intoxicated and were surrounded by open High Gravity Lager cans. All three subjects were advised they were under arrest for trespassing.

Bowling and Barnes were handcuffed without incident. Ofc Chaustit and I attempted to handcuff Traver and he began to resist our efforts to handcuff him. Traver tensed his arms and refused to place them behind his back. Traver was in a seated position while he was not complying with our commands. Ofc Chaustit and I were able to over power Traver and pin him on the ground. Traver continued to keep his arms tense and refuse to put his hands behind his back. Ofc Chaustit and I gave Traver commands to stop resisting. Ofc Chaustit had ahold of Traver's right arm and I had his left. Traver kept his arms rigid and straight out. I delivered a closed handed strike to the back of Traver's left arm between the armpit and elbow (pressure point) to defeat his tensing. We were then able to secure Traver in handcuffs. Ofc Chaustit was able to secure Traver's right arm using only joint manipulation. During Traver's resistance he did not say anything, he just refused to comply with orders given by Ofc Chaustit and I. Traver was not injured as a result of the response to his resistance. Traver then intentionally defecated on himself while in handcuffs. Traver was wrapped in a plastic blanket due to the feces now in and on his shorts.

Barnes, Traver, and Bowling were transported to the MCDC without incident in the KWPD transport van. The van's ICOP was recording the entire time.

While doing the assesment at the jail, the nurse noticed that Barnes' right hand was swollen. She refused to accept him and he was transported to Lower Keys Medical by KWFD Rescue for evaluation. Barnes never complained of pain in that hand. He only complained of chest pains. The ER physician, Dr Jones, advised Barnes had a broken left pinky finger. Dr Jones advised Barnes also had bruising to his right arm consistent with a fall. Dr Jones stated that Barnes' broken finger was consistent with a fall and/or a punching injury by him. Barnes' finger was treated and I transported him back to the MCDC for processing.

Traver, Barnes, and Bowling did enter and remain on the property of 629 Caroline Street behind a wooden fence posted with no trespassing signs without the authorization of the property owner therefore violating FSS 810.09(2)(b) trespass after warning.

Traver did resist efforts to secure him in handcuffs as a result of the arrest for trespassing therefore violating FSS 843.02 resist without violence.
