	On 01-12-2016, I Matthew Hansell of the Key West Police Department was originally dispatched to the Bull and Whistle in reference to a person disturbing customers.
	Upon arrival I observed a white male in a wheel chair personally known to me as Thomas Earl Clement. Key West Police Department over the past several days has received multiple complaints in reference to his erratic behavior and for public urination. Clement has been trespassed from several establishments. Clement was sitting in his wheel chair waving his hands around causing a disturbance. Clement's breath smelled of an alcoholic beverage as he spoke to me.
	I spoke with the manager of The Bull and Whistle, Garcia Quentin who said he wanted Clement moved along as he was bothering customers asking for money.
	I told Clement he needed to find some other place to go for the night and needed to stop bothering customers. Clement became upset told me to fuck off then proceeded to wheel himself across Duval St, blocking traffic.
	I told Clement to stop and that I would assist him with crossing the street. Clement proceeded to ignore me and rolled his wheel chair South on Duval St. toward a stopped car.
	As I walked over to Clement he turned East on Caroline and began to wheel down the street. I waited to see if Clement would leave the area before clearing the call. As I continued to watch Clement, he stood up out of his wheel chair gave me the double middle finger and told me to, " fuck off." He then sat back in his wheel chair and continued to roll East on Caroline St.
	I walked behind Clement as he wheeled toward the curb telling him to, " keep rolling." Clement changed his direction and kept rolling down the street, in the lane of traffic. Since he had no visible lights on his chair, I felt he was in danger of being hit by a vehicle, I grabbed ahold of his wheel chair and directed him toward the South curb of Caroline St.
	Once at the curb I told Clement he was going to jail. Clement asked if it was disorderly conduct. At this point, Clement began to tense his body and pull forward in his wheel chair.
	I took out my handcuffs out and placed one handcuff on Clement's right hand. Clement tensed up and pulled both of his hands underneath his chest leaning forward in an attempt to resist being placed in handcuffs.

Clement continued to argue and tense as I attempted to gain control of his wrist. I requested addition assistance at my location as it was obvious that Clement was being un-cooperative.

Clement cursed and pulled his hands in tighter as I told him numerous times to stop resisting. At one point I told Clement that I was going to tase him if he did not stop resisting.

Clement continued to question why he was being arrested and continued to pull my handcuffs toward his body.

I used my department issued taser in the drive-stun mode and proceeded to drive-stun Clement in his back in an attempt to gain compliance, which was unsuccessful. Clement still refused my commands and was given an additional drive-stun. During the second drive stun Clement pulled away from me again causing me to tase myself. During the second cycle, Clement complied and I direct him to the ground to gain better control where I could handcuff him.

Ofc. Tellier arrived on scene and assisted me with putting Clement into my cruiser. Once in my cruiser, Clement started yelling obscenities which could be heard by people walking on the street. I transported Clement to Monroe County Detention Center, however they required medical clearance due to Clement being tased.

I transported Clement to Lower Keys Hospital where he was evaluated by the emergency room doctor. At Lower Keys Hospital, Sgt. Haley arrived on scene and took photographs of Clement's person and completed a response to resistant report. While at the hospital, Clement was cursing at emergency room staff and causing a disturbance. He further complained of back pain yet still cursed and moved around in his chair. Once medically cleared, Clement was transported to Monroe County Detention Center for processing.

Deputies at the jail conducted a criminal history check of Clement's. I was told that Clement's has numerous convictions for violent felonies. At this time I will be conducting a follow up investigation to determine if further charges are needed.

I contacted Channel 2 dispatch and had them check Clement for all contacts with The Key West Police Department. Clement history of contact began on 12-03-2015 and includes the following.

The incident was captured on BODY CAM as well as in car COBAN. I later returned to the station and had Sgt. Haley download my taser video. A copy of the taser video and BODY CAM video was burnt to disk and I placed it into property.

As I continued to watch Clement, he stood up out of his wheel chair gave me the double middle finger and told me to, "fuck off." He then sat back in his wheel chair and continued to roll East on Caroline St.

I walked behind Clement as he wheeled toward the curb telling him to, "keep rolling." Clement changed his direction and kept rolling down the street. Since he had no visible lights on his chair I felt he was in danger of being hit by a vehicle, I grabbed a hold of his wheel chair and directed him toward the South curb of Caroline St.

Once at the curb I told Clement he was going to jail. Clement asked if it was disorderly conduct. At this point, Clement began to tense his body and pull forward in his wheel chair.

I took out my handcuffs out and placed one handcuff on Clement's right hand. Clement tensed up and pulled both of his hands underneath his chest in an attempt to resist being placed in handcuffs.

Clement's continued to argue and tense as I attempted to gain control of his wrist. I requested addition assistance at my location as it was obvious that Clement was being un-cooperative.

Clement cursed and pulled his hands in tighter as I told him numerous times to stop resisting. At one point I told Clement that I was going to tase him if he did not stop resisting.

Clement continued to question why he was being arrested and continued to pull my handcuffs toward his body.

I used my department issued taser in the drive-stun mode and proceeded to drive-stun Clement in his back in an attempt to gain compliance, which was unsuccessful. Clement still refused my commands and was given an additional drive-stun. After the second drive-stun, Clement complied and I direct him to the ground to gain better control where I could handcuff him.

Ofc. Tellier arrived on seen and assisted me with putting Clement into my cruiser. Once in my cruiser, Clement started yelling obscenities which could be heard by people walking on the street. I transported Clement to Monroe County Detention Center, however they required medical clearance due to Clement being tased.

I transported Clement to Lower Keys Hospital were he was evaluated by the emergency room doctor. At Lower Keys Hospital, Sgt. Haley arrived on scene and took photographs of Clement's person and completed a response to resistant report. While at the hospital, Clement was cursing at emergency room staff and causing a disturbance. Once medically cleared, Clement was transported to Monroe County Detention Center for processing.
