## LEASE AGREEMENT

THIS LEASE AGREEMENT is made this 14th day of January, 1997,  
by and between Michael L. Laughlin, hereinafter referred to as  
"Landlord" and The Mermaid and The Alligator, Inc., hereinafter  
referred to as "Tenant".

W I T N E S S E T HArticle I

## PREMISES

1.1 DESCRIPTION: Landlord hereby leases demised premises to Tenant, and Tenant leases and accepts, subject to the terms and conditions of this lease, the demised premises with improvements thereon located at 729 Truman Boulevard, Key West, Florida 33040.

Article II

2.1 BASE TERMS: The original term of this Lease shall be for a period of three (3) years from the "Commencement Date" hereafter provided unless sooner terminated hereby. Said term, and Tenant's obligation to pay rent, shall commence the date the Tenant takes possession of the building.

2.2 OPTION TO RENEW: Upon completion of the base term of the lease the Tenant shall have the option to renew the lease under the same conditions for an additional period of three (3) years at a rental rate that shall be negotiated and agreed upon by the parties no later than sixty (60) days before the expiration of the base term. Tenant shall give Landlord notice in writing no later than ninety (90) days prior to the end of the lease that he intends to exercise his right to exercise his option right to renew the lease and negotiate a new rental rate. Failure of the Tenant to provide the written notice within the notice time or failure of the parties to reach an agreement on a rental rate within the time set forth hereinabove shall result in the Option to Renew being terminated.

2.3 PRIOR INSTALLATION: Tenant, prior to the commencement of the term, shall with the prior consent of the Landlord be permitted to install fixtures and equipment. Landlord shall have no liability or responsibility for loss of, or any damage to fixtures, equipment or other property of Tenant so installed or placed on the premises.

Article III

## RENT AND OTHER TENANT CONTRIBUTIONS

3.1 MINIMUM RENT: Tenant shall pay the Landlord as rent for the leased premises Ten (10%) Percent of the capital investments made by the landlord which Capital Investment is presently in the amount of Seven Hundred Fifty (\$750,000) Thousand Dollars. The capital investment may increase based on additional improvements which may be made by the landlord. Rental payments shall be made on a monthly basis pro rata over a twelve month per year basis. Payments shall be made on the first day of each month, in advance during the term of this lease at 101 Beaver Dam Road, Aiken, South Carolina 29801 or at such other place as Landlord may designate from time to time.

3.2 LEASE YEAR: The term "lease year" shall mean the twelve (12) month period beginning on the first day of January immediately following the Commencement Date referred to in Article II above and terminating on the succeeding December 31st, or succeeding calendar years.

3.3 PARTIAL YEAR: The term "partial year" shall mean the period beginning with the Commencement Date determined under Article II and the succeeding December 31st, or, in the alternative, shall be the period beginning with the first day of January in the final year of the term of this lease (or any renewal year thereof) and ending on the last day of the term of the lease.

3.4 TAXES: Tenant agrees to pay the landlord all real estate and valorem taxes, including any and all general or special assessments, which may be levied or assessed by any lawful authority for each calendar year during the Lease Term including those assessed against the land and/or building. Tenant agrees to pay the Landlord on the first day of each month of the term in advance such amounts as Landlords shall estimate shall be equal to 1/12th of the annual anticipated taxes for the ensuing year, at the time and place provided for the payment of rent. Upon receipt of the tax bills due for any given year, the Landlord shall compute the taxes due from the Tenant and a summary shall be furnished to the Tenant reflecting the actual amount of taxes due. In the event the amounts paid by the Tenant during preceding period shall be in excess of its tax due, the excess shall be credited against the next ensuing tax payment due from Tenant; in the event the amount paid by the Tenant shall be less than its proportionate share, then it shall pay the remaining balance within ten (10) days after such notice is furnished. The notice furnished Tenant shall also include a computation of the estimate sums that would be due from Tenant each month for the ensuing lease year and the monthly tax payment to be made as aforesaid shall be adjusted accordingly for the ensuing lease year and the initial full tax year will be Seven Thousand Four Hundred Seventy-six and 30/100 Dollars (\$7476.30),

computation of rent, nor any other provision contained herein, nor any acts of the partners hereto.

11.11 PARTIAL INVALIDITY: If any term or condition of this Lease or the application thereof to any person or event shall to any extent be invalid and unenforceable, the remainder of this Lease in the application of such terms, covenant or condition to persons or events other than those to which it is held invalid or unenforceable shall not be affected and each term, covenant and condition of this Lease shall be valid and be enforced to the fullest extent permitted by law.

11.12 SUCCESSORS: The provisions, covenants and conditions of this Lease shall bind and inure to the benefit of the legal representatives, successors and assigns of each of the parties except that no assignment or subletting by Tenant without the written consent of Landlord shall vest any right in the assignee or sublessee of Tenant.

11.13 ESTOPPEL CERTIFICATE: Tenant agrees herewith that it shall from time to time, upon request of Landlord, execute and deliver to Landlord within five (5) days after demand therefore an Estoppel Certificate on Landlord's form certifying inter alia, that this Lease is unmodified and in full force and effect (or if there have been modifications, that the same is in full force and effect as so modified).

I. **TERM AND PARTIES.** This is a lease ("the Lease") for a period of 12 months (the "Lease Term"), beginning 1/15/97 and ending 1/15/98, between Hyman Abdu (State of origin of the principal) and Hermano & TRA, Attorneys, Inc. (In the Lease, the owner, whether one or more, of the property is called "Landlord." All persons to whom the property is leased are called "Tenant.")

II. **PROPERTY RENTED.** Landlord leases to Tenant the land and building located at 916 Windsor Lane, Key West, Florida 33040, together with the following furniture and appliances:  
Stove and refrigerator

(List all furniture and appliances. If none, write "none." If in the Lease the property leased, including furniture and appliances, if any, is called "the Premises.")

III. **RENT PAYMENTS AND CHARGES.** Tenant shall pay rent for the Premises in installments of \$ 1275.00 each on the 15<sup>th</sup> day of each month (A "Rental Instalment Period," as used in the Lease, shall be a month if rent is paid monthly, and a week if rent is paid weekly.) Tenant shall pay with each rent payment all taxes imposed on the rent by taxing authorities. The amount of taxes payable on the beginning date of the Lease is \$ 0 for each instalment. The amount of each instalment of rent plus taxes ("the Lease Payment"), as of the date the Lease begins, is \$ 1275.00. Landlord will notify Tenant if the amount of the tax changes. Tenant shall pay the rent and all other charges required to be paid under the Lease by cash, valid check, or money order. Landlord may appoint an agent to collect the Lease Payment and to perform Landlord's obligations.

The Lease Payment(s) must be paid in advance in amounts (state and) beginning 1/15/97.

IV. **DEPOSITS, ADVANCE RENT, AND LATE CHARGES.** In addition to the Lease Payments described above, Tenant shall pay the following: (check only those items that apply)

a security deposit of \$ 2550.00 to be paid upon signing the Lease.

A. Landlord shall hold the money in a separate interest-bearing or noninterest-bearing account in a Florida banking institution for the benefit of Tenant. If Landlord deposits the money in an interest-bearing account, Landlord must pay Tenant interest of at least 7 1/4% of the annualized average interest (year) by the bank or 6% per year simple interest, whichever is greater (annual), Landlord cannot mix such money with any other funds of Landlord or pledge, mortgage, or make any other use of such money until the money is actually due to Landlord; or

B. Landlord must post a surety bond in the manner allowed by law. If Landlord posts the bond, Landlord shall pay Tenant 6% interest per year. At the end of the Lease, Landlord will pay Tenant, or credit against rent, the amount due to Tenant. No interest will be due Tenant if Tenant lawfully terminates the Lease before the end of the Lease Term.

VI. **NOTICES.** Key West Realty is Landlord's Agent. All notices to Landlord and all Lease Payments must be sent to Landlord's Agent at 109 Duval St., Key West, FL 33040.

unless Landlord gives Tenant written notice of a change. Landlord's Agent may perform inspections on behalf of Landlord. All notices to Landlord shall be given by certified mail, return receipt requested, or by hand delivery to Landlord or Landlord's Agent.
