Tree Species: Strangler Fig (Ficus aurea











Diameter: 21" Location: 60% (roots causing issues) Species: 100% (on protected tree list) Condition: 40% (poor structure, decay in main trunk) Total Average Value = 66% Value x Diameter = 13.8 replacement caliper inches

Recommendation: Recommend approval of the removal of one (1) Strangler Fig tree at 801 Waddell Avenue to be replaced with 13.8 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.


