A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING PURSUANT TO SECTIONS 2-797(4)(b) OF THE CODE OF ORDINANCES THE PURCHASE OF SHORETEL VOIP PHONE SYSTEM EQUIPMENT FROM GOVCONNECTION, INC. FOR GLYNN ARCHER CITY HALL AND OTHER CITY LOCATIONS, IN AN AMOUNT NOT TO EXCEED \$228,947.43; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, City staff performed extensive research to determine a new phone system configuration to best serve the City's current and future telecommunication needs; and

WHEREAS, City staff selected a ShoreTel system, obtained price quotes from at least three vendors, and determined that the quote provided by GovConnection, Inc. was the lowest price, and additionally that it was a lower price than the same products available pursuant to government contract pricing; and

WHEREAS, the City Manager has determined that the purchase of VoiP phone system replacement equipment for Glynn Archer City Hall, and other city locations, as described in the attached

price quote, is in the best interests of the City pursuant to section 2-797(4)(b) of the Code of Ordinances; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of VoiP Phone System Equipment, as described in the attached proposal from GovConnection, in an amount not to exceed \$228,947.43 is hereby approved, pursuant to section 2-797(4) of the Code of Ordinances.

Section 2: That funding for this purchase is budgeted in account 303-1900-519-6200 for FY 15-16.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
