A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING PURSUANT TO SECTION 2-797(4)(b) OF THE CODE OF ORDINANCES THE PURCHASE OF BACK FILE SCANNING SERVICES FROM ADVANCED PROCESSING & IMAGING, INC. (API) IN AN AMOUNT NOT TO EXCEED \$47,726.32; AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT UPON THE ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in preparation for the move into the Josephine Parker City Hall at Historic Glynn R. Archer School, it is necessary to convert a large quantity of paper files which have not reached record retention requirements to electronic records; and

WHEREAS, City staff solicited price quotes from three vendors, and determined that the proposal submitted by API is lowest cost and most responsive to the City's needs; and

WHEREAS, Key West Code of Ordinances section 2-797(4)(b) provides "If in the opinion of the city manager exceptional circumstances exist to exempt a purchase from the competitive bid requirements of this subdivision for the best interests of the city, he shall place a resolution before the city commission for approval of such exemption."; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of back file scanning services from Advanced Processing & Imaging, Inc. (API) in an amount not to exceed \$47,726.32, is hereby approved, pursuant to section 2-797(4)(b) of the Code of Ordinances, best interests of the City.

Section 2: That the City Manager is hereby authorized to execute an Agreement with API, upon the advice and consent of the City Attorney.

Section 3: That funds for this scanning project are budgeted in account number 001-1202-512-5200 for FY 15-16.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
