SUPPLEMENTAL

On Tuesday, March 08, 2016, at approximately 1348 hours, I (Ofc Hall) responded to Key Plaza as back-up.

Ofc Clark was there on a trespasser call and asked for back-up when a male started resisting arrest.

I arrived to find Ofc Clark still struggling with the male subject on the ground in front of his patrol car. I turned my Key West Police Department issued Body Camera on, and ran to assist Ofc Clark.

I kneeled down and immediately grabbed the subject's right arm from under him. I pried his arm out from under him, all while he was resisting by bracing and pulling away from me. I got his right arm out from under him and placed it behind his back, immediately putting it into a handcuff.

Ofc Clark was able to get the subjects left arm behind him and I placed his left wrist into the handcuffs.

Ofc Clark rolled him over and had him sitting up. I then assisted Ofc Clark stand the subject up.

I could see the subject was bleeding from a couple small cuts on his arm and advised the Sergeant via Key West Comm 1.

Ofc Clark then placed the subject in the rear of his patrol car.

The entire call was captured on my body camera and my Coban system.

On Tuesday, 03/08/16, at approximately 1345hrs, I (Ofc. T. Clark), while in full KWPD patrol uniform, observed a trespasser in Key Plaza, 2900 N .Roosevelt Blvd.

On closer approach of the subject, known to me from previous arrests as, Robert Whittington 10/18/53, he looked at me and stopped as he was walking through the parking lot. Before I exited my marked patrol vehicle, Robert threw his bag down to the ground at his feet and said a statement resembling take me to jail come on (cant remember exact) and some obscenities. I activated my Body Worn Camera.

Robert was clearly trespassing on the property again. I have previously arrested Robert for trespassing on the property and trespass warned him from the property. The property is clearly posted in numerous locations with signs authorizing KWPD with permissions to remove trespassers and issue trespass warnings.

I have met with the property manager for Key Plaza, Paul Reese several times in the past reference trespassers and loiters. Paul has expressed numerous complaints and requests to remove trespassers and has given me express permissions to remove subjects from the property. Paul has even provided a notarized letter to KWPD with permissions.

As I began to exit my patrol vehicle Robert walked around my car to the drivers side and was clearly agitated. I gave Robert lawful commands to place both hands on my patrol vehicle so that I may affect an arrest. Robert refused to obey my repeated commands. I gave Robert numerous commands and he refused, repeatedly telling me "No I will not." Robert stared at me in continued defiance.

Robert exhibited slurred speech, glassy/watery/bloodshot eyes and the overwhelming odor of an alcoholic beverage on his breath.

I continued to give Robert numerous commands to place his hands behind his back so I could arrest him, Robert refused. I told Robert he was under arrest and his demeanor did not change. I reached for Roberts right forearm to gain control and place him under arrest. Robert pulled away from my grasp. On my next attempt, Robert grabbed at my arms to pull away and tried to twist from my grasp. A brief struggle ensued as I attempted to gain control over Robert to affect his arrest. I managed to grab Roberts shirt in the front and pulled him to the ground to keep him from escaping. While attempting to pin him to the ground Robert ended up on his side and knocked my camera from my chest as he grabbed at my vest, separating my protective vests right side.

My Body Worn Camera flew from chest with such force it closed.

I informed KWPD COMM1 that I was fighting with Robert who continued to briefly struggle with me as I had him pinned to the ground. A bystander attempted to come to my aide, John Pozzu 09/03/66. I asked Pozzu to stand by as I could hear my back up approaching (sirens). I managed to turn my camera back on as it laid on the pavement as I had Robert pinned.

Pozzu later completed a Sworn Witness Statement provided to KWPD records. The statement did not reflect my initial encounter, only where Pozzu witnessed me holding Robert to the ground.

Ofc. Hall arrived on scene and helped me place Robert under arrest who still was defiant and was pulling his wrists from my grasp. Once handcuffed and secured in my vehicle, EMS Rescue 1 responded to treat Robert for minor cuts on his right forearm and hands. Robert had many previous scab wounds on his person (DURING ALL OF MY PREVIOUS DEALINGS, ROBERT HAS HAD OPEN SORES AND SCABS FROM HEALING SORES ON HIS PERSON). Robert did not complain of any injury.

Ofc Hall and I had some of Roberts blood transfer to our hands and forearms during the struggle (my gloves ripped). We used issued PAWS wipes to decontaminate.

Recue 1 used a cleansing solution on Roberts injuries and placed band aids.

Sgt. R. Allen, Sgt. H. Wood and Ofc. M. Chaustit responded.

Ofc. Chaustit took photos of Roberts visible injuries downloading them into COBAN.

I spoke with the property manager Paul via cellular phone who wished to pursue charges and thanked me for my effort again as this is a constant issue.

Robert has been arrested for trespassing at Key Plaza on 12/28/15 by me. Robert was trespass warned from the property by me on 06/30/15, CAD#C151810138.

I transported Robert to jail. .

Roberts Charges:

1 count: Resisting without violence for failing to obey lawful commands numerous times and attempting escape (pushing/pulling).

1 count: Trespassing after warning, after previous trespass arrests on the property.

This case is cleared by arrest.
