



Topic ORIGINAL

On Tuesday, March 22, 2016 at approximately 0143 hours, I, Ofc. Ane, was on foot patrol on the 200 block Duval Street, Key West, FL when I was flagged down by concerned citizen. The concerned citizen pointed at a black male, later identified as Brannon Woodruff, and advised he was urinating on the sidewalk

I watched Woodruff, who was wearing a white tee shirt and white shorts. It appeared Woodruff was placing his penis back in his shorts. I approached him and saw his shorts zipper was still down. Woodruff smelled strongly of an alcoholic beverage and appeared unsteady on his feet. I asked Woodruff where he was staying and he replied, "I'll beat your fucking ass.". Woodruff then turned towards Ofc. D. Wallis and clenched his fists. Woodruff positioned his body in a fighting stance, with his fists still clenched down by his sides and faced Ofc. D. Wallis. He then told Ofc. D. Wallis that he could "Take him" several times.

Considering that Woodruff was already seen urinating on a sidewalk and was too intoxicated to take care of himself and that due to his aggressive demeanor he would likely be a danger to others. I decided to take Woodruff into protective custody under the Marchman Act.

I positioned myself behind Woodruff and grabbed each one of his wrists. Woodruff immediately started to pull away from me and continued to challenge Ofc. D. Wallis to a fight. I told Woodruff several times to stop resisting or I would take him down. Woodruff ignored my commands and tried to forcefully pull his right arm away from me with his fist clenched. I believed Woodruff was attempting to strike Ofc. D. Wallis. I grabbed Woodruff's shirt, near his right shoulder and conducted a leg sweep on his left leg. Woodruff fell to the ground, striking his head on the pavement. I attempted to place his hands behind his back and he continued to resist me. He tried several times to pull his hands away from me. I was able to place Woodruff into handcuffs (double-locked).

I rolled Woodruff onto his back and sat him up. I saw Woodruff had a small laceration on his forehead. as well as minor swelling. I notified Sqt. M. Haley to respond to my location to document my response to resistance. Ofc. K. Bouvier asked for KWFD Rescue to respond to our location.

Sgt. M Haley arrived on scene and photographed Woodruff's injuries (see RRI report). Woodruff was medically cleared on scene by KWFD Rescue.

I opened the rear door and asked him to step out, which he complied. Woodruff's sandals were on the rear seat of my vehicle, so I placed them on the on the floor and told him to put them on.

Woodruff again became combative and attempted to face me. I turned Woodruff back towards my vehicle and told him to calm down and put his shoes on. Woodruff continued to turned towards and told me several time that he would hurt me. Woodruff began to kick his feet back at me, striking my ankles. Woodruff then started to lean his body into me and attempted to grab my gun belt, while hooking his left leg around my right ankle. I have been involved in martial arts for approximately 9 years and believed Woodruff was attempting to knock me off balance to take me down.

I stepped further in front of Woodruff and conducted a hip-roll, again taking him down. I saw no signs of injury to Woodruff. I asked KWPD COMM 1 to have Detention Deputies bring a restraint chair to my location. I contacted Sgt. M. Haley and notified him that a second take down was performed.

Woodruff was turned over to Monroe County Detention Deputies.

Topic SUPPLEMENTAL

On Tuesday, March 22, 2016 at approximately 0143 hours, Ofc. Ane and I (Officer Wallis) were on foot patrol on the 200 block Duval Street. Ofc. Ane was flagged down in reference to a subject (Brannon Woodruff) urinating on the sidewalk. As Ofc. Ane and I approached Woodruff, I observed Woodruff attempting to zip up his pants. Woodruff had slurred speech, trouble standing and a strong odor of alcohol coming from his person. Woodruff began approaching me and I placed my hand out and stated, "step back please." Woodruff stated, "I can take you, lets go." Ofc. Ane approached Woodruff from behind and grabbed Woodruff's wrists. Woodruff began attempting to pull away from Ofc. Ane. Ofc. Ane gave Woodruff verbal commands to stop resisting. Woodruff did not comply with Ofc. Ane's commands and began turning his body away from Ofc. Ane. Ofc. Ane conducted a leg sweep, placing Woodruff to the ground. I observed Woodruff's head strike the sidewalk as he went to the ground. Ofc. Ane continued to give Woodruff verbal commands to, "Stop resisting." Officer Ane was able to place Woodruff into custody. Sgt. Haley arrived on scene and was briefed on the Key West Fire/Rescue arrived and treated Woodruff on scene. Ofc. Ane placed Woodruff into his patrol vehicle and transported him to MCSO Jail.

My BWC was activated for only a portion of the above events.
