After further speaking with Bethel, I asked him if he had any identification. Bethel said he did not. As I pulled my notepad out to take Bethel's information, Bethel began to walk down the stairs, at fast pace, towards the second floor rear balcony. I pursued Bethel to the second floor. I removed my TASER from my duty belt and switched it to on. I gave Bethel a lawful verbal command to stop and sit down or he would be tased. Bethel ignored my lawful command and took flight, running down the stairs towards the first floor balcony. I pursued Bethel down the stairs. When Bethel reached the bottom of the stairs he turned around towards me, put his hands up and hissed at me. At this point, I felt Bethel was in a attacking mode. After hissing at me, Bethel turned around and began to run again. I deployed my TASER, striking Bethel in the back. Muscular incapacitation took over Bethel's person and he fell to the ground from the first floor balcony.

Ofc. Hammers arrived on scene and handcuffed (double locked) Bethel.

Bethel admitted he was not a guest at the hotel; and he was trespassing. Bethel said he had been up for days and was looking for somewhere to sleep. Search incident to arrest, Bethel's Oho ID was found on his person, which he previously told me he did not have.

Island City House property manager, Michael Herrera arrived on scene. Herrera confirmed Bethel was not a guest and wanted Bethel arrested for trespassing. Herrera said he received several calls from guests about Bethel being on the property.

I contacted KWPD Dispatch to have Key West Rescue respond to the scene reference a laceration on Bethel's chin, from hitting the ground, after being tased.

Ofc. Rodriguez photographed Bethel's injury.
