A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE SOLE-SOURCE PURCHASE OF 40 TASER X26Ps WITH TASER CAM HD, ASSOCIATED ACCESSORIES AND A FIVE-YEAR TASER ASSURANCE PLAN (TAP), PURSUANT TO CITY ORDINANCES SEC. 2-797(1)(A) AND SEC. 2-844 (A) & (B) FROM TASER INTERNATIONAL INC. IN AN INITIAL AMOUNT NOT TO EXCEED \$68,041.04, \$679.38 AND SHIPPING COSTS OF RETURN/DESTRUCTION OF 40 TASER X26E TASERS FOR TAP CREDIT; AUTHORIZING PAYMENT FOR THE TASER THE PLAN(TAP) IN\$12,279.20 ANNUALLY FOR YEARS TWO THROUGH FIVE OF THE TAP PLAN (\$49,113.89 OVER FOUR YEARS); APPROVING THE USE OF LAW ENFORCEMENT TRUST FUND, FEDERAL FORFEITURE ACCOUNT FUNDS FOR THE PURCHASE; PROVIDING FOR AN EFFECTIVE DATE

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of 40 Taser X26Ps, with Taser HD Cams, associated accessories, and a five-year TAP, pursuant to Key West Code of Ordinances sections 2-797(1)(a) and 2-844 (a) & (b), in an initial amount not to exceed \$68,041.04, plus shipping costs of \$679.38 and the return/destruction of 40 Taser X26E Tasers, in accordance with the April 15, 2016 quotation from TASER International, Inc. is hereby approved.

Section 2: That payment in the amount of \$12,279.20 annually for TAP in years two through five is hereby approved (a total of 49,113.84 over four years).

Section 3: That Law Enforcement Trust Fund, Federal forfeiture funds account #172-2113-521-6400 will be used for this purchase. (A total amount of \$117,837.22 inclusive of initial purchase and TAP plan.)

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
