A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDED THE BID OF DOUGLAS N. HIGGINS, INC., IN RESPONSE TO ITB 010-16 FOR SAILFISH PIER REPLACEMENT AT THE CITY MARINA AT GARRISON BIGHT IN THE AMOUNT OF \$1,042,000.00; AUTHORIZING NECESSARY BUDGET TRANSFERS; AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on March 23, 2016, three responsive bids were opened in response to ITB 010-16, Sailfish Pier Replacement - City Marina at Garrison Bight, with Douglas N. Higgins, Inc. submitting the lowest bid; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the bid of Douglas N. Higgins, Inc. in the amount of \$1,042,000.00, inclusive of base bid and alternates, is hereby awarded.

Section 2: A transfer of necessary funds in the amount of \$100,000.00 from Domestic Booster Pump project acct #413-7551-575-6400 and in the amount of \$141,000.00 from Garrison Bight Reserves, to Garrison Bight Infrastructure account 413-7551-575-6300 (GB1503) is hereby approved to fund the total project cost of \$1,042,000. (\$801,000.00 was previously budgeted in FY 15/16.)

Section 3: That the City Manager is authorized to enter into a contract in conformity with the bid documents upon the advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
