Tree Species: Royal Poinciana (Delonix regia)















Diameter: 23.8" Location: 50% (close to utility lines and sewer/water lines. Growing on a raised area of land) Species: 100% (on protected tree list) Condition: 60% (fair) Total Average Value = 70% Value x Diameter = 16.6 replacement caliper inches


