A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ALLOCATION OF FUNDS FOR SUNGARD ONESOLUTION PUBLIC SECTOR TRAINING AND TRAVEL BY SUNGUARD PERSONNEL ON A SOLE SOURCE BASIS IN ACCORDANCE WITH CITY CODE SECTION 2-797(1); PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution 15-303, the City Commission approved a contract with SunGard for OneSolution public sector software;

WHEREAS, the SunGuard contract included a number of training hours, however travel expenses for SunGuard personnel associated with the training, along with a recommended allowance for additional training and travel by SunGuard personnel, were budgeted and to be paid outside of the contract, in accordance with the attached Exhibit 2 titled "Sunguard Public Sector Travel Expense Guidelines;" and

WHEREAS, Key West Code of Ordinances section 2-797(1) permits the purchase of goods and services without competition on a sole source basis under certain specified conditions; and

WHEREAS, City staff recommends the approval of travel and training expenditures in an amount not to exceed \$60,000.00 for SunGuard One Solution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That funds for SunGard OneSolution Public Sector training and travel expenses for SunGuard personnel at a cost not to exceed \$60,000.00 are allocated on a sole source basis, pursuant to section 2-797(1) of the Code of Ordinances.

Section 2: That this purchase is budgeted for FY 15-16 under account 001-1303-513-55.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
