First I spoke with an employee from the 801 Bar who told me he only saw Mr. Jackson in Ms. Vecchio's face while she had her back against a wall. The same employee said that Mr. Jackson was pulling Ms. Vecchio down the street saying "Come on." I then spoke to an employee of The Bourbon Street Pub located at 724 Duval St. The employee told me he saw Mr. Jackson grab Ms. Vecchio by the arm and throw her. When I asked for clarification the employee described a push. The employee said Ms. Vecchio never fell to the floor. The Manager of The Bourbon Street Pub said it would take at least a week to review the security footage.

After speaking to the employees of The Bourbon Street Pub I spoke to Ms. Vecchio. Ms. Vecchio denied ever being struck by Mr. Jackson and did not have any visible injuries. Ms. Vecchio did say that Mr. Jackson was being aggressive and grabbed her. Ms. Vecchio made it clear she did not wish to pursue charges.

Although Ms. Vecchio refused to pursue charges against Mr. Jackson for grabbing her, it was clear to me that Mr. Jackson was intoxicated to the point he could be a danger to others or himself. As a result of Mr. Jackson's level of intoxication, I decided to take Mr. Jackson into protective custody.

I explained to Mr. Jackson that he was not under arrest and that he could be released as soon as he was sober. Ms. Vecchio also told Mr. Jackson that no charges were being filed and that he was only being detained for his safety.

While transporting Mr. Jackson to the jail he began to hit his head against the partition in the patrol car.

Once I arrived at the jail, I saw Ofc. A. Ane in the sally port. I asked Ofc. A. Ane for his assistance in case Mr. Jackson became violent.

When I asked Mr. Jackson to step of the car, he refused. I asked Mr. Jackson no less that five more times to exit the patrol car and he refused each time. I then removed my KWPD issued Chemical Spray from its pouch and began to shake the container in an effort to ensure the chemicals in the spray were properly mixed in the event I had to use force to remove Mr. Jackson from the car.

Once Mr. Jackson saw the chemical spray in my hand he said "If you spray me I'll fuck your fucking world, you fat bitch." After my repeating step out of the car three more times, Mr. Jackson finally stepped out of the car.

Once Mr. Jackson was out of the car, Ofc. A. Ane and I each grabbed an arm and began escorting Mr. Jackson towards the entry doors of the detention center. Mr. Jackson pulled his arm away from me in an attempt to break my hold. I asked Mr. Jackson to "Stop pulling away and please calm down." Mr. Jackson responded by saying "Get the fuck off my arm." while yanking his arm away from me in an attempt to defeat my efforts to control him. As a result Ofc. A. Ane and I redirected Mr. Jackson into the elevator door in an effort to control him. It was at the point Mr. Jackson began grabbing at my outer carrier and my shirt. Mr. Jackson than began kicking at me, kicking me at least once on my left leg.

Due to Mr. Jackson's aggressive resistance, I used my KWPD issued chemical spray to spray Mr. Jackson in the face in an effort to defeat his actions.

The chemical spray was effective and Mr. Jackson stopped kicking immediately.

I explained to Mr. Jackson that he was not under arrest and that he could be released as soon as he was sober. Ms. Vecchio also told Mr. Jackson that no charges were being filed and that he was only being detained for his safety.

While transporting Mr. Jackson to the jail, he began to hit his head against the partition in the patrol car.

Once I arrived at the jail, I saw Ofc. A. Ane in the sally port. I asked Ofc. A. Ane for his assistance in case Mr. Jackson became violent.

When I asked Mr. Jackson to step of the car he refused. I asked Mr. Jackson no less that five more times to exit the patrol car and he refused each time. I then removed my KWPD issued Chemical Spray from its pouch and began to shake the container in an effort to ensure the chemicals in the spray were properly mixed, in the event I had to use force to remove Mr. Jackson from the car.

Once Mr. Jackson saw the chemical spray in my hand he said "If you spray me I'll fuck your fucking world, you fat bitch." After my repeating step out of the car, three more times, Mr. Jackson finally stepped out of the car.

Once Mr. Jackson was out of the car, Ofc. A. Ane and I each grabbed an arm and began escorting Mr. Jackson towards the entry doors of the detention center. Mr. Jackson pulled his arm away from me in an attempt to break my hold. I asked Mr. Jackson to "Stop pulling away and please calm down." Mr. Jackson responded by saying "Get the fuck off my arm." while yanking his arm away from me in an attempt to defeat my efforts to control him. As a result, Ofc. A. Ane and I redirected Mr. Jackson into the elevator door in an effort to control him. It was at the point, Mr. Jackson began grabbing at my outer carrier, and my shirt. Mr. Jackson than began kicking at me, kicking me at least once on my left leg.

Due to Mr. Jackson's aggressive resistance, I used my KWPD issued chemical spray, to spray Mr. Jackson in the face in an effort to defeat his actions.

The chemical spray was effective and Mr. Jackson stopped kicking immediately.

As the elevator door opened Mr. Jackson and I both fell out of the elevator.

Mr. Jackson was immediately placed in a restraint chair by detention staff. As soon as detention staff was able to gain compliance of Mr. Jackson, he was allowed to shower. Mr. Jackson was also seen by medical staff at the Detention Center.

SUPPLEMENTAL

On Sunday, April 10, 2016 at approximately 0245 hours, I, Ofc. Ane, was in the Monroe County Detention Center's (MCDC) sally port, located at 5501 College Road, Key West, FL, when Ofc. K. Bouvier arrived with a black male, Bryan Jackson, who was in protective custody under the Marchman Act.

Ofc. Bouvier asked me to help him escort Jackson into the booking lobby of MCDC, because Jackson was being combative. Ofc. K. Bouvier opened his back door, where I saw Jackson leaning over. Ofc. K. Bouvier asked Jackson to exit his vehicle several times. Jackson ignored Ofc. K. Bouvier and kept his head down. Ofc. K. Bouvier continued to ask Jackson to exit the vehicle. Jackson sat up and began to curse at Ofc. K. Bouvier. Jackson advised he was a "Fucking PJ" and "Killed people". Ofc. K. Bouvier displayed his pepper spray and told Jackson to exit the vehicle or he would be sprayed. Jackson was still being verbally combative, and tensing up but he did exit the vehicle. Ofc. K. Bouvier and I escorted Jackson into a lobby and waited for an elevator that lead to MCDC's booking area.

While waiting for the elevator, Jackson continued to pull away from Ofc. K. Bouvier and I. I attempted to speak to Jackson and told him there were no pending charges against him and he would be released once he was able to care for himself.

Once the elevator door opened, Jackson thrashed and pulled his arm away from Ofc. K. Bouvier and yelled for Ofc. K. Bouvier to "let him the fuck go". Ofc. K. Bouvier and I pushed Jackson into the elevator door in an attempt to gain control of him. Jackson became more aggressive and kicked his left leg back at Ofc. K. Bouvier in an attempt to strike him. I again braced Jackson against the elevator door and told him not to kick at Ofc. K. Bouvier. Jackson continued to resist Ofc. K. Bouvier and I.

Ofc. K. Bouvier then deployed his pepper spray at Jackson's head. The elevator door opened and Jackson, Ofc. K. Bouvier and I fell to the ground in booking area. Several MCSO Deputies then grabbed Jackson and placed him into restraint chair.

I asked for a supervisor to respond to our location to document the above incident. See RRI report.

This investigation was recorded via my department issue body worn camera. I later uploaded the video to the COBAN server.
