




An application was received requesting the removal of **(1) Frangipani tree**. A site inspection was done on May 27, 2016 and documented the following:

Tree Species: Frangipani (Plumeria sp.)


















Diameter: 17.5" Location: 50% (Impacting fence and growing into the electrical feeder lines to the property.) Species: 50% (not on protected or not protected tree list) Condition: 50% (fair, poor structure, strong lean) Total Average Value = 50% Value x Diameter = 8.7 replacement caliper inches

Recommendation: Recommend approval of the removal of one (1) Frangipani tree at 1321 Simonton Street to be replaced with 8.7 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.
