



An application was received requesting the removal of **(1) Strangler Fig tree**. A site inspection was done on May 27, 2016 and documented the following:

Tree Species: Strangler Fig (Ficus aurea)













Diameter: 25"

Location: 40% (close to driveway and house. Impacting handicap walkway)

Species: 100% (on protected tree list)

Condition: 50% (fair)

Total Average Value = 63%

Value x Diameter = 15 replacement caliper inches

Recommendation: Recommend approval of the removal of one (1) Strangler Fig tree at 1801 Venetia Sreet to be replaced with 15 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.
