

An application was received requesting the removal of (1) Pigeon Plum, (1) Jamaican Dogwood, and (1) Yellow Tabebuia tree. A site inspection was done on May 27, 2016 and documented the following:









Diameter: 7.9" Location: 80%

Species: 100% (on protected tree list)

Condition: 40% (fair overall, poor structure-codominant trunks)

Total Average Value = 73%

Value x Diameter = 5.7 replacement caliper inches

Tree Species: Jamaican Dogwood (Piscidia piscipula)



Diameter: 5" Location: 70%


Species: 100% (on protected tree list)


Condition: 50% (fair)

Total Average Value = 73%

Value x Diameter = 3.6 replacement caliper inches

Tree Species: Yellow Tabebuia (Tabebuia caraiba)









Diameter: 8.2"

Location: 60% (utility lines run through canopy)

Species: 50% (not on protected or not protected tree list)

Condition: 60% (fair)

Total Average Value = 56%

Value x Diameter = 4.6 replacement caliper inches

Recommendation: Recommend approval of the removal of one (1) Pigeon Plum, (1) Jamaican Dogwood tree, and (1) Yellow Trumpet tree at 2412 Linda Avenue to be replaced with 13.9 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.
