An application was received requesting the removal of **(1) Bottlebrush tree**. A site inspection was done on May 27, 2016 and documented the following:

Tree Species: Bottlebrush (Callistemon viminalis)
















Diameter: 23.5"

Location: 40% (tree is uplifting and damaging front fence. Growing

primarily over neighbor's property)

Species: 50% (not on protected or not protected tree list)

Condition: 50% (fair health, tree lopsided)

Total Average Value = 46%

Value x Diameter = 10.8 replacement caliper inches

Schefflera tree also to be removed-no permit required.

In October 2010, a tree removal permit was issued to remove this tree. The property owner at that time decided not to remove the tree.

Recommendation: Recommend approval of the removal of one (1) Bottlebrush tree at 724 Caroline Street to be replaced with 10.8 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.




