(21) Sea Grape, (5) Blackbead, (3) Buttonwood, (1) Poisonwood, (1) Seven year Apple tree, (1) Shortleaf Fig, and (1) Coconut Palm in order to build a new access road into Fort Zachary Taylor Park. Most of the trees are currently growing on fill piles. Attempts will be made during construction to transplant as many trees as possible to adjacent park property.

In accordance with Sec 110-327, the approval to remove 80 Gumbo Limbo, 46 Jamacian Dogwood, 21 Sea Grape, 5 Blackbead, 3 Buttonwood, 1 Poisonwood, 1 Seven Year Apple, 1 Shortleaf Ficus & 1 Coconut Palm. If all the trees are removed, required replacement of 504 caliper inches of FL #1 dicot or fruit tree(s) and (1) Native Palm, 4ft tall from approved list be planted on Ft Zachary Taylor park property. Submit an updated tree status report within 4 months of the date of the permit to the Urban Forester documenting which trees are to be transplanted and which are to be removed. Trees that are transplanted must be tagged with their tree identification number and their new location marked on a map and transplant date noted. Transplanted trees must survive at least one year from the date of transplanting and the Urban Forester must be contacted in order to document transpalnting. The required replacements for the transplanted trees will be subtracted from the overall total.
