

An application was received requesting the removal of **(1) Royal Poinciana tree**. A site inspection was done on July 1, 2016 and documented the following:

Tree Species: Royal Poinciana (Delonix regia)
















Diameter: 17.5" Location: 60% (very close to property line. Impacting fence. Very visible tree from road) Species: 100% (on protected tree list) Condition: 30% (poor, large area of decay near base of tree. Large heavy canopy) Total Average Value = 63% Value x Diameter = 11 replacement caliper inches

Recommendation: Recommend approval of the removal of one (1) Royal Poinciana tree at 1216 Packer Street to be replaced with 11 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.


