An application was received requesting the removal of **(1) Gumbo Limbo and (1) Sapodilla tree**. On July 12, 2016 approval was given to remove the Gumbo Limbo tree. The Tree Commission postponed a decision on the Sapodilla tree pending additional information from neighboring residences.


A site inspection was done on June 15, 2016 and documented the following: Sapodilla

Value x Diameter = 23.9 replacement caliper inches

Recommend DENIAL of removal of Sapodilla tree (Sec 328.1-species and size of tree make it a unique specimen).

The Sapodilla tree in Mr. Bready's yard has become a big concern for us and our neighbors, as it has grown to the point it now threatens all our properties. This tree lunges away from Mr. Bready's property, leaning out over our property and the properties of our fellow neighbors here in the Meadows. It is a difficult tree to trim. We have had it trimmed in the past, but it could not be trimmed to the point it did not pose a threat to the safety of our home and surrounding property. In addition, this tree has a propensity to attract rats and there is no way to remove that threat without removal of the tree. We have young children living in the home behind us, and the liability of this tree and it's health concerns from the rats should not be ignored.

We welcome commission members to view this tree from our property, so that you may see first hand the reasons for our concerns, and the need for your support in this tree's removal.

I have been in this home for over 5 years and find this tree to a be hazard to me and my neighbors, and our properties. I have also been a resident and property owner in Key west since 2001.

However, this tree has grown disproportionately with the surrounding area, nearby structures and trees. This particular tree has also grown with a slant towards my neighbors property's. Multiple branches have fallen onto my home and caused damage. The tree attracts rats and they can be seen frolicking along the fence line and back up into the tree on a minute by minute basis.

The property here at 1319 is a double lot and was planted with an over abundance of trees and plants, thus the overcrowding. While I am a huge supporter of keeping Key west green, I do not support the idea of this tree threatening our personal safety and our property's buildings.
